The Court:

Having seen the accusations brought against the accused David Lee Wells II holder of American Passport with number 480415365.

Accused that:

On the 23rd of April 2013 between 18:00pm and 18:30pm, whilst being in St. Julian's:

1. Reviled, or threatened, or caused bodily harm to any person lawfully charged with a public duty, while in the act of discharging their duty or because of them having discharged such duty, or with intent to intimidate or unduly influence them in the discharge of such duty;
2. Furthermore, with having on the same date, time, place and circumstances, assaulted or resisted by violence or active force not amounting to public violence, any person lawfully charged with a public duty when in the execution of the law or of a lawful order issued by a competent authority;
3. Furthermore, with having on the same date, time and place, without intent to kill or to put the life of PC 670 Walter Sheldon in manifest jeopardy caused the mentioned PC 670 Walter Sheldon slight injuries as certified by Dr. M. Spiteri holder of medical register number 2666, of the Mater Dei Hospital;
4. Furthermore, with having the same date, time, place and circumstances, used force against PS 690 James Robert Magro, PC 670 Walter Sheldon and PC 502 Clifford Frendo with intent to insult, annoy or hurt them or others;
5. Furthermore, with having on the same date, time, place and circumstances, wilfully disturbs the public good order or the public peace;
6. Furthermore, with having on the same date, time, place and circumstances, disobeyed the lawful orders of any authority or of any person entrusted with a public service;
7. Furthermore, with having on the same date, time and place wilfully committed any spoil, damage or injury to or upon any movable or immovable property, which the amount of damage does not exceed twenty-three Euro and twenty-nine cents (€23.29) to the detriment of the Government of Malta.

Read the documents and accusations;

Heard the evidence produced under oath;

After having seen Articles 95, 96, 221 (1), 222 (1) (c), 325 (1) (d) u 338 (1) (ee) of Chapter 9 of the Laws of Malta.

Kopja Informali ta' Sentenza

The Court has read the report of the three Psychiatric Experts and on the basis of this declares a non guilty verdict in the regard of the accused.

The accused has assured this Court that he will be leaving the Maltese Islands by the end of the week and in view of this declaration, the Prosecution is hereby returning to the attorney of the accused his passport.

The case has been decided and the accused was not found guilty of the accusations brought against him by the Prosecution.

The Court explained the consequences of the judgement to the accused.
