Bober Andrey Alekseevich age 25 years, son of Bober Aleksey Petrovich and Galina nee` Elmanova born Russia, on the 2<sup>nd</sup> October, 1987, residing at 'Pechenga', Ship, Valletta Docks, Malta and holder of Russian Passport No. 7510056

The Court;

Informal Copy of Judgement

Having seen charges brought against accused who were charged with having on the night between the 11<sup>th</sup> June 2013 and 12<sup>th</sup> June 2013, whilst in St. Julians and on these islands:

1. Committed theft of handbag which theft was aggravated by time and value which exceeds two hundred and thirty two euro and ninety-four cents ( $\in$ 232.94 but does not exceed two thousand three hundred and twenty nine euros and thirty seven cents ( $\in$ 2,329.37) to the detriment of Angelica Falzon;

2. Committed theft of handbag which theft was aggravated by time and value which exceeds two hundred and thirty two euro and ninety-four cents ( $\in$ 232.94 but does not exceed two thousand three hundred and twenty nine euros and thirty seven cents ( $\in$ 2,329.37) to the detriment of Gayle Grech;

3. Further on the same date, time, place and circumstances committed theft of photographic equipment, make Fujifilm which theft was aggravated by time to the detriment of unknown person/s

Having seen documents exhibited;

Having seen the Attorney General's consent for the case to be dealt summarily by this Court;

Having heard accused plead guilty to the charges brought against them which guilty plea was reaffirmed after the accused were given adequate time to reconsider same.

Having heard submissions regarding the punishment to be inflicted;

Considers;

That in view of the guilty plea filed by the accused the Court finds them guilty as charged.

Informal Copy of Judgement

That in considering the punishment to be inflicted the Court is taking into consideration the early guilty plea filed by the accused, their cooperation with the police during investigations and the fact that goods stolen were returned to the injured parties.

Consequently the Court after having seen sections 261(c)(f), 267, 270, 279(a) and 280(1) of Chapter 9 of the Laws of Malta and section 32(1)(c) of Chapter 217 of the Laws of Malta finds accused guilty as charged and condemns them to a period of one (1) year imprisonment which period of imprisonment after having seen Section 28A of Chapter 9 of the laws of Malta is being suspended for 2 years from today.
