**The Court:**

Having seen the accusations brought against the accused Yilmaz Gotza holder of Identification Card Number 12291F.

**Accused that:**

On the 20<sup>th</sup> August 2013 on these Islands between 07:20 in the evening and the 08:20 in the evening.

1. Assaulted or resisted by violence or active force not amounting to public violence, any person lawfully charged with a public duty when in the execution of the law or of lawful order issued by a competent authority mainly PS297 T Baldacchino and PC1264 S Cumbo;
2. Moreover reviled, or threatened, or cause a bodily harm to any person lawfully charged with a public duty, while in the act of discharging his duty or because of his having discharged such duty, or with intent to intimidate or unduly influence him in the discharge of such duty, mainly PS297 T Baldacchino and PC1264 S Cumbo;
3. And moreover as a person under sentence and any other prisoner escaped from the custody to the person or persons charged with his custody mainly that of PS297 T Bladacchino and PC1264 S Cumbo;
4. And moreover caused slight injuries on the person of PS297 T Baldacchino and PC1264 S Cumbo as certified by Dr Christopher Deguara Reg. No. 3033 of the Floriana Health Centre;
5. And moreover wilfully committed any spoil, damage or injury to or upon any movable or immovable property when he caused damage to one of the main doors of the Msida Police Station to the detriment of the Malta Police Force, which damage does not exceed one hundred and sixteen euro and forty seven cents (€116.47);
6. And moreover with his course of conduct cause Matthew Cremona to fear that violence will be used against him of his property or against the person or property of any of his ascendant, descendants.

The court is requested to provide for the safety of Matthew Cremona by applying provisions of Article 412C of Chapter 9 of the laws of Malta.

**The Court:**

Read the documents and accusations;

Heard the evidence produced under oath;

After having seen Articles 95 (1), 96, 151, 221 (1), 325 (1) (c) and 251 B of Chapter 9 of the Laws of Malta.

Informal Copy of Judgement

After hearing the evidence on oath of Dr. Joseph Spiteri, the accused is not in a good mental state, the Court decides the case exhausted as per Article 44 of the Health Act of Chapter 262 of the Laws of Malta given that he shall be recovered in Mount Carmel Hospital.

The Court explained the consequences of the judgement to the accused.
