The Court;

Having seen charges brought against accused who was charged with having on the 3rd August 2013, between 01:00am and 02:00am, whilst being in St. Julian's:

1. Wilfully committed any spoil, damage or injury to or upon any movable or immovable property, which the amount of damage does not exceed one thousand one hundred sixty four Euros and sixty nine cents (€1,164.69),

but exceeds one hundred sixteen Euros and sixty seven cents to the detriment of Tania Formston.

2. Further with having on the same date, time, place and circumstances wilfully committed any spoil, damage or injury to or upon any movable or immovable property, which the amount of damage does not exceed one thousand one hundred sixty four Euros and sixty nine cents (€1,164.69), but exceeds one hundred sixteen Euros and sixty seven cents to the detriment of Hugo Chetcuti.

Having seen documents exhibited;

Having seen the Attorney General's consent dated 28th June, 2011, for the case to be dealt summarily by this Court;

Having heard accused admit to the charges brought against him which admission was reaffirmed after the accused was given adequate time to reconsider same.

Having heard submissions regarding the punishment to be inflicted;

Considers;

That in view of the guilty plea filed by the accused the Court finds him guilty as charged.

That in considering the punishment to be inflicted the Court is taking into consideration the early guilty plea filed by the accused and the fact that the accused will pay the damages caused by him to the injured parties.

Consequently the Court after having seen sections 325(1)(b) and 17(h) of Chapter 9 of the Laws of Malta and finds accused guilty as charged and condemns him to a period of seven months imprisonment which period of imprisonment after having seen section 28A of Chapter 9 of the Laws of Malta is being suspended for a period of two years from today.

Informal Copy of Judgement

The Court is warning the convicted person of the consequences according to law should he commit another crime during the operative period of this sentence.

After having seen Section 28H of Chapter 9 the Laws of Malta the Court orders the convicted person to pay Hugo Chetcuti the sum of eight hundred eighteen euros and ninet two cetns (€819.92) and Tania Formson the sum of two hundred and seventy euros (€270) and this within two weeks from today.

Finally the Court orders that a copy of the sentence together with the acts of the proceedings be forwarded to the Attorney General according law.
