Razvan-Aurel Stefan Marian Ciucisan Alexandra Buzatu Marius Stefan

The Court;

Having seen the accusations brought against:-

**Razvan-Aurel Stefan**, 22 years son of Gheorghe u Valeria nee' Vanea, born Romania on the 4<sup>th</sup> October 1981, residing in Malta at an unknown address and holder of ID card number, issued in Romania no. RT615409 and;

**Marian Ciucisan** 51 years son of Viktor and Gabriella nee' unknown born Romania on the 9<sup>th</sup> may 1962, residing in Malta at an unknown address and holder of Romanian I D Card Number 804965

**Alexandra Buzatu**, 22 years, daughter of Sterica and Erika nee Boyros, born in Romanian, on the 25<sup>th</sup> October 1989 residing in Malta at an unknown address and holder of Italian ID Card no: AT 0528547

**Marius Stefan**, 34 years, son of Georghe and Valeria nee Vanea born in Romania on the 24<sup>th</sup> January 1979, residing in Malta at an unknown address and holder of Romanina passport bearing number 12538051

Being charged, altogether, with having committed several acts, even if at different times, which constitute violations of the same provision of the law, and which were committed in pursuance of the same design and therefore;

#### Razvan-Aurel Stefan alone with having:

On the 8<sup>th</sup> July 2013, at about 11:35 a.m, whilst at 'Putirjal' in Floriana, committed theft of a wallet containing several items including cash, having a total value of  $\notin 70$  to the detriment of Philip Brown of British nationality,

And also with having on the  $16^{th}$  August 2013, at about 11:30 a.m. whilst at 'Putirjal' in Floriana committed theft of a wallet containing several items including cash, having a total value **€18**, to the detriment of Antonio Manuel Arruda Ribeiro Marques of Portuguese nationality;

And also with having on the  $20^{th}$  August 2013, during the period between 08:00am and 10:00am whilst at 'Putirjal' in Floriana committed theft of a wallet containing several items including cash, having a total value **€40**, to the detriment of Isabelle Marie Desiree of French nationality;

And also with having on the 22<sup>nd</sup> August 2013, at about 11:15am whilst in the Maltese Islands on a route bus,

committed theft of a wallet containing several items including cash, to the detriment of Nazionale Erwin of Italian nationality which offence of theft is aggravated by value exceeding the sum of  $\in$  232.94 but not exceeding the sum of  $\notin$  232.937;

And also with having on the 23<sup>rd</sup> August 2013, at about 12:15pm whilst at 'Putirjal' in Floriana, committed theft of a wallet containing several items including cash having a total value of €320 to the detriment of Franz Henke of German nationality which offence of theft is aggravated by value exceeding the sum of €232.94 but not exceeding the sum of €2,329.37 and was committed on a person who has attained the age of sixty years of age;

## Razvan-Aurel Stefan and Alexandra Buzatu together with having:

And also with having on the 9<sup>th</sup> of August 2013, at about 08:00pm whilst in the Maltese Islands on a route bus, committed theft of a wallet containing several items including cash having a total value of  $\in$ 70 to the detriment of Gaetana Gunn of Maltese nationality which offence was committed on a person who has attained the age of sixty years of age;

#### Marius Stefan alone:

With having on the  $25^{th}$  of August 2013, at about 06:30pm whilst in the Maltese Islands on a route bus, committed theft of a wallet containing several items including cash having a total value of  $\in$ 150 to the detriment of Peter Doleysi of Cypriot nationality which offence is aggravated by the nature of thing stolen;

And also with having on the  $21^{st}$  August 2013, at about 1:00pm whilst in Sliema, committed theft of a wallet containing several items including cash, having a total value of  $\notin$ 400, to the detriment of Martirano Giacomo of Italian nationality which offence of theft is aggravated by value exceeding the sum of  $\notin$ 232.94 but not exceeding the sum of  $\notin$ 2,329.37;

And also with having on the  $19^{th}$  August 2013, at about 5.30pm whilst at 'Putirjal' in Floriana committed theft of a wallet containing several items including cash, having a total value  $\textbf{\in 20}$ , to the detriment of Wilson Javier Saavendra of Colombian nationality;

And also with having on the  $11^{th}$  August 2013, at about 11.30am whilst at 'Putirjal' in Floriana committed theft of a wallet containing several items including cash, to the detriment of Julian Tucki of British nationality, which offence of theft is aggravated by value exceeding the sum of €232.94 but not exceeding the sum of €2,329.37;

And also with having on the  $11^{th}$  August 2013, at about 10.00am whilst in the Maltese Islands on route bus committed theft of a wallet containing several items including cash, having a total value **€140**, to the detriment of Agnese Mattonai of Italian nationality, which offence of theft is aggravated by the nature of thing stolen;

And also with having on the  $22^{nd}$  August 2013, at about 6.30pm whilst in the Maltese Islands on a route bus, committed a theft of an I-phone 5, having a total value **€700**, to the detriment of Carolina Katarzina of Polish nationality, which offence of theft is aggravated by value exceeding the sum of €232.94 but not exceeding the sum of €2,329.37 and by the nature of thing stolen;

#### Alexandra Buzatu alone with:

having on the 27<sup>th</sup> July 2013, at about 10:45 am whilst in the Maltese Islands on a route bus, committed a theft of a wallet, including other items having a total value **€620**, to the detriment of Luc Lejeune of French nationality, which offence of theft is aggravated by value exceeding the sum of €232.94 but not exceeding the sum of €2,329.37 and by the nature of thing stolen;

And also with having on the 21<sup>st</sup> August 2013, at about 10.30am whilst at 'Putirjal' in Floriana committed theft of a

wallet containing items of unknown vale to the detriment of Raule Mitrano of Italian nationality;

#### Marius Stefan and Razvan-Aurel Stefan together with:

having on the 27<sup>th</sup> July 2013, at about noon whilst in St. Julians, committed theft of a wallet containing several items including cash having a total value exceeding €300 to the detriment of Barry Nicholson of British nationality which offence of theft is aggravated by value exceeding the sum of €232.94 but not exceeding the sum of €2,329.37 and committed on a person who has attained the age of sixty years;

And further with having on the 9<sup>th</sup> July 2013, at about 10:00am whilst in the Maltese Islands on a route bus, committed theft of a wallet containing several items including cash having a total value exceeding  $\in$ 40 to the detriment of Willot Pierre of Belgian nationality which offence of theft is aggravated by the nature of thing stolen;

And further with having on the 24<sup>th</sup> August 2013, at about 02:30pm whilst in the Maltese Islands on a route bus, committed theft of a wallet containing several items including cash having a total value of  $\in$ 700 in addition to 1,200 Australian Dollars to the detriment of Willot Pierre of Belgian nationality which offence of theft is aggravated by value exceeding the sum of  $\in$ 232.94 but not exceeding the sum of  $\in$ 232.937 and with the nature of thing stolen;

And also with having on the  $11^{\text{th}}$  August 2013, at about 9.15pm whilst at 'Putirjal' in Floriana committed theft of a wallet containing several items including cash, having a total value **€30**, to the detriment of Christian Hosselaer of Belgian nationality;

# Alexandra Buzatu, Razvan-Aurel Stefan and Marian Ciucisan together with:

having on the 13<sup>th</sup> July 2013, at about 10:45am whilst in the Maltese Islands on a route bus, committed theft of a wallet containing several items including cash having a

total value exceeding  $\in$  320 to the detriment of Giorgio Tartari of Italian nationality which offence of theft is aggravated by value exceeding the sum of  $\in$  232.94 but not exceeding the sum of  $\in$  2,329.37 and by the nature of thing stolen;

And also with having on the 19<sup>th</sup> August 2013, at about noon whilst in the Maltese Islands on a route bus, committed theft of a wallet containing several items of unknown value to the detriment of Antonio Ellul of Maltese nationality which offence of theft is aggravated by the nature of thing stolen and which was committed on a person who has attained the age of sixty years;

# Marian Ciucisan and Alexandra Buzatu together with having:

On the 28<sup>th</sup> July 2013, during the period between 4:00pm and 5:00pm whilst in the Maltese Islands on a route bus, committed theft of a wallet containing several items including theft of cash, having a total value of  $\in$ 125 to the detriment of Joseph Attard of Maltese nationality which offence of theft is aggravated by the nature of thing stolen and which was committed on a person who has attained the age of sixty years;

With having on the 26<sup>th</sup> August 2013, at about 10:10am whilst in Sliema, committed theft of a wallet containing several items including cash having a total value exceeding €380 to the detriment of Antonio Simetti of Italian nationality which offence of theft is aggravated by value exceeding the sum of €232.94 but not exceeding the sum of €2,329.37;

## Marius Stefan, Razvan-Aurel Stefan and Alexandra Buzatu with:

having on the 19<sup>th</sup> August 2013, at about 2.00pm whilst at 'Putirjal' in Floriana committed theft of a wallet containing several items including cash, having a total value of about **€200**, to the detriment of William Stuart Roscoe of British nationality;

#### Marius Stefan and Alexandra Buzatu together with:

having on the 30<sup>th</sup> July 2013, at about 12:50pm whilst in McDonalds in Valletta, committed theft of a wallet containing several items including cash having a total value exceeding  $\in$ 450 to the detriment of Bernd Steinbather of German nationality which offence of theft is aggravated by value exceeding the sum of  $\in$ 232.94 but not exceeding the sum of  $\in$ 2,329.37;

Therefore, after exhibiting the relative documents of the above mentioned persons, we request that this case be investigated according to law.

Having heard the plea of guilt of each accused as registered in the first sitting of the 30August, 2013;

Having seen the records of the case;

Finds the accused guilty as charged;

Having seen articles 18, 261(c) and (g), 267, 271, 279(a), 282 and Schedule D of Chapter 9 of the Laws of Malta;

Having seen the conduct sheet of the accused representative only of their conduct during their stay in Malta;

Having considered that the commission of this crime is a new phenomenon in Malta more so when it is committed in an organized manner such as in this case, the Court feels that it is duty bound to prevent a further escalation of this phenomeno by sending a strong message to would be perpetrarors of this crime and therefore commits the accused to a term of imprisonment of thirteen (13) months from today.

Since the prosecution did not have the consent of the attorney general for this case to be tried summarily, the Court orders that these acts be transmitted to the attorney general within the time prescribed by law.
