The Court;

Having seen the accusations brought against Florin Taiteanu, 41 years, son of Vasile and Joana nee' Rosca, born in Romania on the 16<sup>th</sup> May, 1972, residing at Judetul, Galati, Romania and holder of Romanian passport bearing number 13528026;

Charged with having on the 11<sup>th</sup> March 2014 and in the days prior to this date in these islands:

Had in his possession the drugs (cocaine) specified in the First Schedule of the Dangerous Drug Ordinance, Chapter 101 of the Laws of Malta, when he was not in possession of an import or an export authorisation issued by the Chief Government Medical Officer in pursuance of the provisions of paragraphs 4 and 6 of the Ordinance, and when he was not licensed or otherwise authorised to manufacture or supply the mentioned drugs, and was not otherwise licensed to manufacture or supply the mentioned drugs, and was not otherwise licensed by the President of Malta or authorised by the Internal Control of Dangerous Drugs Regulations (G.N. 292/1939) to be in possession of the mentioned drugs, and failed to prove that the mentioned drugs was supplied to him for his personal use, according to a medical prescription as provided in the said regulations, and this in breach of the 1939 Regulations, of the Internal Control of Dangerous Drugs (G.N. 292/1939) as subsequently amended by the Dangerous Drugs Ordinance Chapter 101, of the Laws of Malta.

The Court is requested that besides awarding the punishment prescribed by law, orders the accused to pay expenses related to the appointment of experts in terms of Sec. 533 Cap 9 of the Laws of Malta.

## Kopja Informali ta' Sentenza

Having seen the order of the attorney general for the accused to be brought and tried before this Court;

Having heard the plea of guilt of the accused as registered in the first sitting held today being the date of his arraignment;

Having seen the records of the case;

Finds the accused guilty as charged;

Having seen sections 4 and 6 of Chapter 101 of the Laws of Malta and GN292/1939;

Having seen the clean conduct sheet of the accused;

Discharges the accused with the specific condition that he does not commit any other offence within a period of one (1) year from today in terms of article 22 of Chapter 446 of the laws of Malta. The Court proceeded by explaining to the accused his obligations under this judgement.

The Court also orders the destruction of the exhibit and appoints the Registrar of Court to execute such an order.
