- 1.1 Illi huma għandhom erbgha u ghoxrin sehem indiviz minn hamsa u ghoxrin (24/25), ta' hanut numru 54, Triq William Reid, il-Gzira, kif notifikat fl-istess rikors guramentat promotur;
- 1.2 Illi l-istess fond hu mizmum in komun u ilu hekk għal aktar minn ghaxar (10) snin minn wara l-mewt ta' Celestina Camilleri;
- 1.3 Illi s-sehem rimanenti gej mill-propjeta` ta' Carmelo Micallef kif ukoll hemm indikat, li pero` l-werrieta tieghu m'humiex magħrufin;
- 1.4 Illi r-rikorrenti jixtiequ jbieghu il-fond *de quo* lil Stefan u Anne Marie Cutajar għall-prezz ta' tmintax –il elf Ewro, (€18,000.00);

  - 6.2. Illi tawtorizza l-bejgh tal-fond fuq riferit 54, Triq William Reid, il-Gzira lill-imsemmija konjugi Stefan u AnneMarie Cutajar ghall-prezz ta' tmintax –il elf Ewro, (€18,000.00);

- 6.3. Illi tordna li z-zewg kuntratti indikati fir-rikors promotur jigu redatti minn Nutar Dottor Nicholas Briffa kif mitlub, u dan fi zmien tlett (3) xhur mid-data ta' din is-sentenza u f'post li l-istess Nutar jidhirlu xieraq;
