Vs

Mustafa Adam Hamud, 28 years old, son of Adam and Ifrax nee Ismaciil, born in Mogadishu Somalia, on the 8<sup>th</sup> of February 1987 and residing at Blk Q, Flat 3, FrankDebono Street, Marsalforn limits of Zebbug Gozo and holder of ID.

The Court;

Having seen the charge brought forward against the accused for having on the night between the 19<sup>th</sup> & 20<sup>th</sup> December 2013 at different places in Marsalforn limits of Zebbug, Gozo;

1. Willfully committed any spoil, damage or injury to or upon any movable or immovable property belonging to any other persons which damage exceeds the amount of two hundred and fifty euro (€250) but does not exceed the amount of two thousand and five hundred euro (€2,500) to the detriment of Rodney Camilleri, Emanuel Saliba, Jason Attard, Maria Rosaria Refalo and Raymond Fenech in breach of Art. 325(1)(b) of Chapter 9 of the Laws of Malta.

The Court is kindly being requested that in the case the accused is found guilty, orders the offender to pay to the injured parties the sum of money as may be determined by the court as compensation for any loss or damage caused to them.

Having heard the guilty plea of the accused to the charges brought against him the Court has no alternative but to declare the accused guilty of all the charges brought against him.

With regards to punishment the Court took into consideration the fact that the accused pleaded guilty at an early stage of the proceedings, the circumstances of the case, and that he co-operated with the Police.

The Court after having seen articles 325(1)(b) of Chapter 9 of the Laws of Malta upon his admission finds the accused guilty of the charges brought against him and by application of article 22 of Chapter 446 of the Laws of Malta, discharges him on condition that he does not commit another offence within a period of one (1) year from date of this judgement and in terms of article 24 of Chapter 446 of the Laws of Malta imposes a period of three months from today for the accused to pay to the amount of two hundred and sixty nine euro ( $\in$ 269), ((Rodney Camilleri eighty Euro ( $\in$ 80), Emanuel Saliba fourteen Euro ( $\in$ 14), Jason Attard forty five Euro ( $\in$ 45), Maria Rosaria Refalo fifty Euro ( $\in$ 50) and Raymond Fenech eighty Euro ( $\in$ 80) )as damages suffered by the parte civile.

The Court explained to defendant in ordinary language of the consequences should he commit another offence within the period of one year.
