The Court;

After seeing the charges brought against;

Amy Rebecca Colwill, 25 years, born in UK, on the 14 June 1989, and resides at 78 Thornlaw Road London and holder of British passport number 527274851;

Elizabeth Grace Morrison Squire , 26 years, born in UK, on the 19 March 1989, and resides at Flat 15 Warley House Mitchison Road London and holder of British passport number 110696043;

Amy Suzanne Gina Harris, 25 years, born in UK, on the 30 May 1989, and resides at 19 Turnpike Lane London and holder of British passport number 506723110;

With having;

- 1) On the 04 April 2015 at about 01:15 hrs at Qawra L/O St Paul's Bay willfully committed any spoil, damage to or upon any movable or immovable property i.e., a vehicle make BMW bearing registration number BMW-137 to the detriment of Johann Aquilina holder of ID card number 235179(M), which damage does not exceed the sum of €2,500 in terms of article 325(1)(b) Chapter 9 of the Laws of Malta;
- 2) Moreover you are being accused for having on the same day, time and place, willfully committed any spoil, damage to or upon any movable or immovable property i.e., a vehicle make Renault Clio bearing registration number IBO-486 to the detriment of Johann Aquilina holder of ID card number 235179(M), which damage does not exceed the sum of €2,500 in terms of article 325(1)(b) in terms of article 325 Chapter 9 of the Laws of Malta;

Considers;

After having seen Articles 325(1) (b) and 325 of Chapter 9 of the Laws of Malta.

After having heard the evidence and the documents exhibited;

After having heard the accused **Amy Rebecca Colwill** and **Elizabeth Grace Morrison Squire** admit the charges brought against them, which admission was confirmed by them after having been given time to reconsider in accordance with the law;

The Court finds the said accused **Amy Rebecca Colwill** and **Elizabeth Grace Morrison Squire** guilty as charged, discharges them from any punishment on condition that they do not commit another offence within the period of three (3) years from today, in accordance with the provisions of Article 22 Chapter 446 of the Laws of Malta.

The Court furthermore orders that the accused effect payment of the sum of one thousand, two hundred and seventy euro (€1,270) in accordance with the provisions of Article 24 Chapter 446 of the Laws of Malta by way of damages caused to the vehicles mentioned in the proceedings.

The Court does not find the said accused **Amy Suzanne Gina Harris** guilty and acquits her from the charges as indicated.

The Court explained in clear words the terms of the judgement to the accused.
