Rat ir-rikors ta' Josephine Camilleri et li permezz tieghu wara li gie premess illi:

Huma ghandhom erbgha u ghoxrin sehem mhux maqsum minn hamsa u ghoxrin (24/25) tad-dar jisimha "Sagra Familja House", numru mija u wiehed ittra "B" (101B), fi Triq il-Kbira, Naxxar, bl-arja libera taghha, libera u franka, bi-drittijiet u l-pertinenzi taghha kollha.

Din il-proprjeta ilha in komun ghal aktar minn ghaxar snin, u l-komunjoni nholqot bil-mewt ta' Celestina Camilleri fil-11 ta' April 1994 meta ntirtet mill-awturi tar-rikorrenti f'isimha indivizi. Minn dakinhar is-sidien bdew il-qsim tal-proprjeta li minnha fadal din il-proprjeta flimkien ma' ohrajn li huma mikrija lil terzi.

Is-sehem l-iehor mill-proprjeta huwa tal-wirt ta' Carmelo Micallef, li miet fid-9 ta' Jannar 2002. Il-werrieta tieghu ma humiex maghrufa billi wliedu, li kienu msejha ghall-wirt, irrinunzjaw ghall-wirt bi tliet noti, numri 376, 377 u 378 tat-12 ta' Marzu 2002 fis-Sekond'Awla tal-Qorti Civili, u n-neputijiet tieghu, li kienu msejha ghall-wirt wara r-rinunzja ta' l-ulied, ukoll irrinunzjaw ghall-wirt b'nota numru 245/2007 tas-7 ta' Mejju 2007 fil-Qorti Civili, Sezzjoni ta' Gurisdizzjoni Volontarja.

Din il-proprjeta giet stmata bil-prezz ta' mija u sittax-il elf Euro (€116,000) mill-Perit Vittorio Bonavia, imma ma setax jinstab bejgh ghaliha bil-prezz moghti minnu. Ir-rikorrenti jixtiequ jbieghu d-dar "Sagra Familja House" li hija proprjeta komuni lil Victor Grech (I.D. 247858M) u Jane Leslye Rebecca Bannister

Grech (I.D. 0012359A) mizzewgin Grech bil-prezz ta' tmenin elf euro (€80,000). Ghalkemm dan il-bejgh huwa fl-interess tal-komproprjetarji kollha, ma jistax isir il-kuntratt billi l-wirt ta' Carmelo Micallef ma jidher hadd ghalih.
