Rat ir-Rikors ipprezentat minn Martin Degiorgio fis-6 ta' Lulju 2006 permezz ta' liema jitlob li prevja dikjarazzjoni li bhala l-awtrici ta' l-artikoli intestati "Black shirts and blacker hearts" u "Martin and friends make the news", liema artikoli gew ippubblikati fil-gazzetta "The Malta Independent on Sunday" fl-edizzjoni tal-21 ta' Mejju 2006 u tat-18 ta' Gunju 2006 rispettivament, Daphne Caruana Galizia hija responsabbli ta' malafama u libel fil-konfront tieghu stante li siltiet mill-imsemmija pubblikazzjonijiet kienu malafamanti u libelluzi peress illi l-iskop tagħhom kien li jtellef jew inaqqas ir-reputazzjoni tieghu, l-istess Daphne Caruana Galizia tigi kkundannata thallsu dik is-somma li tigi likwidata mill-Qorti ai termini ta' l-Artikolu 28 tal-Kap. 248 tal-Ligijiet ta' Malta, liema somma ma teccedix hamest elef Lira Maltin (Lm5,000), bl-ispejjez u bl-imghaxijiet legali dekoribbli sad-data ta' l-effettiv pagament kontra Daphne Caruana Galizia, u b'riserva għal kull azzjoni ohra spettanti lilu;

artikoli ma johrog *animus injuriandi* rikjest mill-Ligi fil-konfront ta' l-attur personalment.

Tul ix-xhieda li ta quddiem il-Qorti waqt is-seduta tat-3 ta' Lulju 2007⁶, l-attur esebixxa l-artikoli meritu ta' dawn il-proceduri⁷ w' indika liema siltiet partikolari mill-imsemmija artikoli huma fil-fehma tieghu malafamanti u libelluzi fil-konfront tieghu.

Mill-artikolu intestat “Black shirts and blacker hearts” l-attur indika s-segmenti siltiet bhala li huma malafamanti u libelluzi fil-konfront tieghu; *Nobody would suggest that Norman Lowell and his black-shirts – or for that matter Philip Beattie, Martin De Giorgio and their Assocjazzjoni Nazzjonali Reppublikana – are about to seize power, forcing us to live under fascism. Our electoral system militates against small political movements, as Alternattiva Demokratika very well knows. Even if the system changes and the fascists succeed in obtaining seats in Parliament, they will never make it to government or even to opposition. But that is an irrelevant argument because fascists are not interested in democracy. ... The danger is that they are fanning a frenzy of fear and hatred in the present: fear and hatred of the ‘outsider’ and, by extension, fear and hatred of other Maltese who point out that they are wrong-headed and that their views imperil our democratic way of life and our upholding of human rights and individual liberties. Of course, neither Lowell’s Imperium Europa nor Beattie’s and De Giorgio’s ANR call themselves fascist. They say instead that they are “far right” conscious of the negative sentiments that the word fascism triggers in those with common sense and respect for the rights and dignity of others. But the reality of what we are does not emerge from our own perception of ourselves, nor through how we define our beliefs, but based on the facts of what we say and do, and how we think. On this basis, Imperium Europa and the ANR are fascist organizations. ... Beattie and De Giorgio will be dismayed at being compared with Lowell. They like to think of themselves as the acceptable face of fascism – on in their words, the “far right” – while Lowell hovers on the crackpot fringe. They attempt to disassociate themselves from him without condemning his views or mentioning his name. ... Karmenu Mifsud Bonnici did not shoot Raymond Caruana dead or ransack the halls of justice and the seat of the archbishop, but he failed to control the violence of the mob. These are things we lived through – bombs, deaths, shootings, ransacking, threats, fear – so why are we now behaving as though it is out of the question for rabid followers of an extremist organization to set fire to the property of those who criticize them? We, more than others, should know that it is not just entirely possible, but that it is almost certainly the correct explanation of what has been happening. After all we have lived through this kind of thing already.*

Mill-artikolu intitolat “Martin and friends make the news” l-attur indika s-segwenti siltiet bhala li huma malafamanti u libelluzi fil-konfront tieghu; *Mr. Degiorgio recently said how important the ANR is, because all sorts of foreign journalists are interviewing him. He doesn't seem to realize that it is the importance of a freak show. This is how he was reported in the IHT: “We are a close-knit society and the migrants are, destroying our culture, Degiorgio said from his car, with DVX – the Latin letters for ‘Duce’, the title of the Italian fascist dictator Benito Mussolini – written on his licence-plate, Degiorgio said he would warn that the Africans risked turning Malta into the toilet of the Mediterranean. Islam took Malta by force, and now the Africans are invading us silently⁸,’ he said*”. Mr. Degiorgio may sell a lot of trips to other countries, but I don't think he's doing much to sell trips to Malta. Joanne Micallef, prolific writer of letters to the newspapers on the issue of illegal immigration, has revealed herself on Xarabank as a member of the ANR. No wonder she was so keen to pounce on me publicly for saying that it was the fascists who tried to burn my house down (with us inside it) and no wonder she leapt so quickly to the defence of Arlette Baldacchino – whom Norman Lowell calls his “Etoile” – when I wrote about her recently. Indeed, when I think about it, every letter written in support of Arlette, and published in this newspaper a couple of weeks ago, came from supporters and activists of the ANR and of Lowell's Imperium Europa. Gosh, what a surprise. I just wish they would declare their interest, instead of pretending to be genuinely disinterested readers. Arlette repaid the compliment by turning up to bolster the meager numbers at the ANR “rally of thousands”, joined to Norman Lowell's hip, of course. He repaid a compliment of his own, by telling the Xarabank cameras that when he and “Etoile” call a rally, it will be enormous⁹.

Dan huwa konfermat kemm minn dak li ntqal kif ukoll fdak li nikteb minni ghan-nom ta' l-ANR. Nixtieq nghid li jiena dejjem ghamiltha cara li ahna nemmnu fis-seklu 2007 u nemmen fi process politiku demokratiku. It-twemmin tieghi huwa vicin hafna ta' l-Alleanza Nazzjonali ta' l-Italja li b'partiti konservattivi ... Jiena bniedem ukoll nazzjonalist li nemmen ... fl-imhabba tan-nazzjon. Effettivament ma nissimpaticzax ma' nies li llum il-gurnata ... politici li kienu jezistu sittin, sebghin, tmenin sena ilu. ... l-artikolu in kwistjoni inkiteb fi zminijiet meta kien hemm hafna hruq għaddej fil-pajjiz. In sostenn ta' l-eccezzjonijiet tagħha l-konvenuta xehdet illi *qrajt ix-xhieda li ta s-Sur Martin Degiorgio u dak li qed ighid huwa bhala fatt li huwa m'huwiex faxxist*. Nixtieq nghid però li minn diskors li jghid hu jidher li huwa faxxist ghax faxxist huwa bniedem li jemmen fit-twemmin estrem. Qed nesebixxi dokument li qed jigi mmarkat bhala dokument CGD li hemm definizzjoni ta' xi tfisser faxxismu. ... l-istess Martin Degiorgio attirali l-attenzjoni tieghi bi speeches u kitba tieghu. Mill-ewwel indunajt u ghidt possibbli hemm nies li għadhom jahsbu hekk fit-twemmin? Il-Qorti kkunsidrat il-provi kollha prodotti u l-posizzjonijiet rispettivi tal-partijiet kontendenti u tqis li l-artikoli li l-konvenuta kitbet dwar u b'referenza ghall-attur huma bhala fatt malafamanti u libelluzi fil-konfront tieghu u bl-ebda mod jista' jitqies li hija kienet qed tagħmel *fair comment* dwar kwistjonijiet ta' interess pubbliku u kritika accettabbli f'socjetà demokratika.

Fl-artikoli in kwistjoni l-konvenuta bla tlaqliq ta' xejn tħid li l-attur huwa faxxist u fix-xhieda li tat quddiem il-Qorti waqt is-seduta ta' l-4 ta' Frar 2008 ittenni li fil-fehma tagħha l-politika ta' l-attur hija *wahda purament faxxista*¹⁷. Biex issosstni l-posizzjoni tagħha l-konvenuta esebiet definizzjoni ta' faxxizmu u cioè *a political system based on a very powerful leader, state control and extreme pride in country and race, and in which political opposition is not allowed*¹⁸ u *a political philosophy, movement or regime (as that of the Fascisti) that exalts nation and often race above the individual and that stands for a centralized autocratic government headed by a dictatorial leader, severe economic and social regimentation, and forcible suppression*

In effetti in kontro-ezami waqt is-seduta tal-15 ta' Dicembru 2009 il-konvenuta ddikjarat ulterjorment illi *mistoqsija nispjega ghaliex qed nghid illi fil-fatt l-attur Martin Degiorgio jemmen fit-twemmin estrem u li fil-fatt kien hemm diversi diskorsi nghid illi Martin Degiorgio jifforma parti mill-group maghruf bhala ANR u llum il-gurnata ma għandux parti minnu jew jekk fil-fatt l-ANR għadux jezisti jew le jiena però ma nafx u l-ANR kien partit politiku ta' l-extreme lemin. L-ANR kien jesebixxi twemmin fondamentali tal-politika tal-lemin estrem. ... Li tirrikonoxxi li hemm problema minhabba l-immigrazzjoni hija haga però li bniedem jesprimi l-opinjoni tieghu proprju kontra n-nies gejjin mill-pajjizi ta' l-Afrika hija kwistjoni ohra. Fil-fehma tal-Qorti l-uzu da parte tal-konvenuta ta' l-appellativ faxxist firrigward ta' l-attur ma kienx intiz bhala deskriżżjoni ta' l-ideologiji tieghu kif minnha issa affermat, izda kelle l-iskop uniku ta' attribuzzjoni negattiva fil-konfront ta' l-attur fil-firxa socio-politico kollha tagħha.

Fl-analizi sottomessa mill-konvenuta ghall-konsiderazzjoni ta' din il-Qorti dwar x'inhi l-ideologija faxxista, l-istess konvenuta għad illi tat definizzjoni ta' x'inhu fäxxizmu u ta' x'inhu fäxxist, naqset milli ssemmi jew tittratta dwar il-konnotazzjonijiet negattivi u n-natura pegorattiva li t-termini fäxxismu u fäxxist għandhom fis-socjetà odjerna. In oltre hija bbazat l-analizi u konsegwenti asserżjonijiet tagħha fuq il-fatt li fuq il-website ta' l-Alleanza Nazzjonali Repubblikana kien hemm *links* ghall-partit Taljan Alleanza Nazionale u ghall-blog A Voice from the Right ta' certu Lawrence Auster u minhabba osservazzjoni magħmula minn Arlette Baldacchino, membru tal-partit Imperium Europa fuq il-forum tal-website ta' Viva Malta, mingħajr però ma ndagat ulterjorment fuq dawn l-elementi u konnessjonijiet.

Illum il-gurnata, partikolarment fiz-zminijiet ta' wara t-Tieni Gwerra Dinjija u il-grajjiet horox li sehhew matulha, huwa rikonoxxut li t-termini fäxxismu u fäxxist għandhom konnotazzjonijiet ferm negattivi u huma termini pegorattivi intizi l-iktar bhala insult. Jigi osservat illi *as a political epithet, fascist has been used in an anti-authoritarian sense to emphasize the common ideology of governmental suppression of individual freedom. In this sense, the word fascist is intended to mean oppressive, intolerant, chauvinist, genocidal, dictatorial, racist, or aggressive. George Orwell wrote in 1944: ...the word 'Fascism' is almost entirely meaningless. In conversation, of course, it is used even more wildly than in print. I have heard it applied to farmers, shopkeepers, Social Credit, corporal punishment, fox-hunting, bull-fighting,*

the 1922 Committee, the 1941 Committee, Kipling, Gandhi, Chiang Kai-Shek, homosexuality, Priestley's broadcasts, Youth Hostels, astrology, women, dogs and I do not know what else ... Except for the relatively small number of Fascist sympathisers, almost any English person would accept 'bully' as a synonym for 'Fascist'. That is about as near to a definition as this much-abused word has come²⁰.

Il-Qorti hija tal-fehma li fil-kaz in ezami l-intenzjoni tal-konvenuta, li kjarament hija opposta ghall-ideologija appertament kontra l-immigrazzjoni ta' l-attur, wara l-attribuzzjoni fil-konfront tieghu tat-terminu faxxist fl-artikoli mertu tal-kontestazzjoni kienet wahda purament ta' insult u xejn iktar. Dana johrog car ukoll mill-mod sommarju li kkonkludiet li l-attur huwa faxxist minhabba *links* li kienu jidhru fuq il-website ta' l-Alleanza Nazzjonali Repubblikana ghall-partit politiku Taljan Alleanza Nazionale u ghall-blog A Voice from the Right immexxi minn Lawrence Auster.

Ghad illi tohloq konnotazzjoni negattiva a bazi tal-link fuq il-website ta' l-Alleanza Nazzjonali Repubblikana ghall-partit politiku Taljan Alleanza Nazionale, il-konvenuta evidentement naqset milli tikkonsidra bil-mod opportun l-ideologija ta' tali partit għaliex altrimenti kienet issir taf li l-Alleanza Nazionale ma kenix tabbraccja l-ideologija faxxista, anzi tant iddisassocjat ruhha minnha li certa membri tal-partit – fosthom Alessandra Mussolini neputija ta' Benito Mussolini – kienu telqu w a loro volta iddisassocjaw ruhhom mill-partit in kwistjoni.

In effetti minn rickera li il-Qorti għamlet dwar dan il-partit politika, ricerka li facilment setghet anzi messa saret mill-konvenuta wkoll, irrizulta li: *National Alliance, launched in 1994, was officially founded in January 1995, when the Italian Social Movement (MSI), the former neo-fascist party, merged with conservative elements of the former Christian Democracy, which had disbanded in 1994 after two years of scandals and various splits due to corruption at its highest levels, exposed by the Mani pulite investigation, and the Italian Liberal Party, disbanded in the same year. Former MSI members were however still the bulk of the new party and former MSI leader Gianfranco Fini was elected leader of the new party. The AN logo followed a template very similar to that of the Democratic Party of the Left, with the logo of the direct predecessor party in a small circle, as a means of legally preventing others from using it. The name was suggested by an article on the Italian newspaper Il Tempo written in 1992 by Domenico Fisichella, a prominent conservative academic. Starting in the 1990s, the MSI gradually transformed into a mainstream right-wing party, culminating in its 1995 dissolution into AN. The party was part of all three House of Freedoms coalition governments led by Silvio Berlusconi. Gianfranco Fini was notably nominated Deputy Prime Minister after the 2001 general*

election and was Foreign Minister from November 2004 to May 2006. When Gianfranco Fini visited Israel in late November 2003 in the function of Italian Deputy Prime Minister, he labeled the racial laws issued by the fascist regime in 1938 as "infamous", as also Giorgio Almirante, historic leader of MSI, had done before. He also referred to the Italian Social Republic as belonging to the most shameful pages of the past, and considered fascism part of an era of "absolute evil", something which was hardly acceptable to the few remaining hardliners of the party. As a result, Alessandra Mussolini, the granddaughter of the former fascist dictator Benito Mussolini, who had been at odds with the party on a number of issues for a long time, and some hardliners left the party and formed Social Action²¹. ... National Alliance's political program emphasized: traditional values, being often close to the position of the Roman Catholic Church, despite some social liberal and secular attitudes; the United States and European integration; prohibition of all drugs, including marijuana. Distinguishing itself from the MSI, the party distanced itself from Benito Mussolini and Fascism and made efforts to improve relations with Jewish groups. With most hardliners leaving the party, it sought to present itself as a respectable conservative party and to join forces with Forza Italia in the European People's Party and, eventually, in a united party of the centre-right²². Although the party approved the market economy and held favourable views on liberalizations and the privatization of state industries, however AN was to the left of Forza Italia on economic issues and sometimes supported statist policies. That is why the party was strong in Rome and Lazio, where most civil servants live. Moreover AN presented itself as a party promoting national cohesion, national identity and patriotism. Regarding institutional reforms, the party was a long-time supporter of presidentialism and a plurality voting system, and came to support also federalism and to fully accept the alliance with Lega Nord, although the relations with that party were tense at times, especially about issues regarding national unity. Gianfranco Fini, a moderniser who saw Nicolas Sarkozy and David Cameron as role-models, impressed an ambitious political line to the party, combining the pillars of conservative ideology like security, family values and patriotism with a progressive approach in other areas such as stem cell research and supporting voting rights for legal aliens. Some of these positions were not shared by many members of the party, most of whom staunchly opposed stem cell research and artificial insemination.

Lawrence Auster u x'kienet l-ideologija tieghu. Minn ricerka li ghamlet il-Qorti, mill-gdid jigi ribadit rickera li facilment setghet anzi messa ghamlet il-konvenuta wkoll, jirrizulta li dan Lawrence Auster kien *an American traditionalist conservative blogger and essayist. He was best known within traditionalist conservative circles for his writings on immigration and multiculturalism ... Auster was a strong conservative who primarily identified as a "traditionalist" who opposed the liberalism of modern western society. His interests were primarily social policy, particularly the politics of gender, sex, religion, sexuality, culture, patriotism, and identity. He was also a frequent commentator on day-to-day American politics. Auster was not shy about describing himself profoundly alienated from modern America, and he considered most institutions of American society, including both political parties, to be corrupted by liberal philosophy.* Auster wrote, *"I have always called myself a racialist, which to me means two things. First, as a general proposition, I think that race matters in all kinds of ways. Second, I care about the white race. It is the source of and is inseparable from everything we are, everything we have, and everything our civilization has achieved."* However, he chose not to self-identify as a white nationalist, and, as a tactical matter, accepted the conventional definition of racism as having *"the connotation of the morally bad, of oppression and hatred."*²³

Minn ricerka ulterjuri li l-Qorti ghamlet dwar *tradionalist conservatism* jirrizulta li *Traditionalist Conservatism, also known as Traditional Conservatism, Traditionalism, Classical Conservatism and (in the United Kingdom and Canada) Toryism, is a political philosophy emphasizing the need for the principles of natural law and transcendent moral order, tradition, hierarchy and organic unity, agrarianism, classicism and high culture, and the intersecting spheres of loyalty.* Some traditionalists have embraced the labels *"reactionary"* and *"counterrevolutionary"*, defying the stigma that has attached to these terms since the Enlightenment. *Traditionalism developed in 18th-century Europe (particularly in response to the English Civil War and the French Revolution). In the middle of the 20th century it started to organize itself in earnest as an intellectual and political force. This more modern expression of traditionalist conservatism began among a group of U.S. university professors (labeled the "New Conservatives" by the popular press) who rejected the notions of individualism, liberalism, egalitarianism, modernity, and social progress, promoted cultural and educational renewal, and revived interest in the Church, the family, the state, local community, etc.*²⁴

Ghalkemm il-partit politiku Taljan Alleanza Nazionale u Lawrence Auster kieni ihaddnu ideat nettament kontra l-immigrazzjoni w indubbjament l-attur jaqbel ma' tali ideat, fatt dan li huwa qatt ma pprova jahbi ghaliex apertament

iddikjara il-posizzjoni tieghu fir-rigward ta' l-immigrazzjoni u flimkien ma' ohrajn holoq il-grupp Alleanza Nazzjonali Repubblikana proprio bhala *anti-immigration pressure group*, b'daqshekk ma jfissirx li l-Alleanza Nazionale u Lawrence Auster u per konsegwenza l-attur huma faxxisti bl-implikazzjoni kif intiza mill-konvenuta.

In effetti diversi studjuzi dwar il-faxxizmu, bhal ad ezempju Roger Griffin, iddeterminaw l-elementi kostituttivi ta' l-ideologija faxxista u jargumentaw illi *fascism is best understood as a series of propositions or ‘myths’. For this reason, he [Roger Griffin] follows Payne in listing those characteristics which could be said to make up the fascist minimum. To Griffin, fascism is anti-liberal, anti-conservative, charismatic, anti-rational, socialist, totalitarian, racist and eclectic. He suggests that fascism emerges when a nation perceives itself to be in crisis; he also maintains – like Payne – that it has no common class basis of support. Griffin, however, goes beyond Stanley Payne, arguing that there is one single thread which links this ‘common mythic core’, which is nationalism. Fascism, Roger Griffin believes, is best understood as a form of nationalism, as ‘a genus of political ideology whose mythic core in its various permutations is a palingenetic form of populist ultra-nationalism’. This phrase, ‘palingenetic ultra-nationalism’ is Griffin’s recurring definition. The word ‘palingenetic’ means rebirth, so fascism is a form of nationalism that describes ‘its’ nation as decadent and in need of rebirth through a nationalist revolution. Fascism then is ultra- or revolutionary-nationalism. The interpretation offered by these historians clearly diverge. Griffin argues that fascism and Nazism are different from one another, though at the same time linked, through a common mythic core. Sternhell, however, simply maintains that Hitler was no fascist. Despite these differences there are far more significant areas over which the historians agree. For example, Eatwell, Griffin, Sternhell and Payne all adhere to the method, derived from Max Weber, of an ‘ideal type’. They generate an ‘ideal fascist’ by presenting a list of carefully selected ideas of fascism out of which they then construct a ‘fascist minimum’. If a group or individual adheres to the greater number of these fascist ideas, then the adherent themselves is fascist. This method enables historians to distinguish fascism from other conservative nationalisms, such as Christian fundamentalism or more traditional Conservatism²⁵.*

Fl-ewwel lok minn dokument esebit mill-konvenuta stess a fol. 103 tal-process jirrizulta li kuntrarjament ghal dak minnha affermat fix-xhieda tagħha, fit-13 ta' Ottubru 2006, ossia dakinhar stess li Arlette Baldacchino għamlet id-dikjarazzjonijiet tagħha fil-konfront ta' l-attur²⁷, l-istess attur istitwixxa proceduri ta' libel fil-konfront tagħha. In effetti minn dan id-dokument li huwa estratt minn The Malta Independent Online intitolat *ANR frontman sues "Viva Malta" spokeswoman for libel u datat 14 ta' Ottubru 2006, jirrizulta li Alleanza Nazzjonali Repubblikana (ANR – National Republican Alliance) frontman Martin Degiorgio yesterday filed a libel suit over articles published on the Viva Malta website. The libel suit was filed against Viva Malta spokeswoman Arlette Baldacchino, the author of a number of articles that Mr. Degiorgio claimed were libelous and defamatory, and were aimed at tarnishing his reputation...* Fil-fehma tal-Qorti l-fatt li l-attur istitwixxa dawn il-proceduri ta' libel fil-konfront ta' Arlette Baldacchino jxejjen dak li tipprova timplika l-konvenuta fix-xhieda tagħha, u cioè li fin-nuqqas ta' proceduri ta' libel l-attur gie li implicitament ammetta li kien jinsab f'dan l-avveniment imsemmi minn Baldacchino.

Il-konvenuta tikkontendi wkoll li l-posting li deher fuq il-forum tal-webiste ta' Viva Malta taht l-isem Baron Ironblood – esebit a fol. 62 tal-process – kien posting ta' l-attur peress huwa kien jikteb taht dan l-isem Baron Ironblood. In effetti fix-xhieda li tat quddiem il-Qorti waqt is-seduta tad-9 ta' Mejju 2008²⁸, il-konvenuta ddikjarat li *l-ahhar riferenza huwa dokument CGD9 li huwa posting fuq internet forum mingħand Martin Degiorgio li huza n-nickname Baron Iron Blood li wkoll jagħmel referenza għal Adolf Hitler who is one of the most significant personalities of the 20th Century Third Reich tal-Germanja u kliem simili.* Hawn hekk kjarament il-konvenuta qed tipprova tallaccja lill-attur mal-kuncett tal-faxxismu, jekk mhux addirittura tan-nazzismu, izda ma ressqa l-ebda prova, li fl-ahhar mill-ahhar kellha l-obbligu li tressaq, li sodisfacientement tikkorobora l-affermazzjoni tagħha li effettivament kien l-attur li għamel il-posting in kwistjoni.

Filwaqt illi l-Qorti fermament temmen li l-konvenuta għandha kull dritt li ma taqbilx ma' l-ideologiji u politika ta' l-attur fir-rigward tal-kwistjoni ta' l-immirgrazzjoni u konsegwentement għandha kull dritt li tikkritikah f'tali rigward, tali kritika trid tkun wahda meqjusa u proporzjonata u mhux ingurjiza u malafamanti.

B’danakollu, kif għajnej rilevat, kemm il-Qorti Ewropeja kif ukoll il-Qrati tagħna dejjem qaghdu attenti illi filwaqt li rrikonoxxew stampa hielsa fpajjiz demokratiku ammoneuw ukoll illi dik kellha tkun “stampa responsabbli li kienet obbligata wkoll illi entro l-limiti stabbiliti, topera bir-rispett xieraq tal-persuni li jattiraw l-attenzjoni tagħha bhala oggett ta’ kritika jew

kumment" ("Onorevoli Perit Charles Buhagiar -vs- Ray Bugeja noe", Appell, 25 ta' Mejju, 2001.) **Bhala konsegwenza dan iwassal ghall-osservazzjoni li ma jistax ikun accettat illi taht il-parvenza tal-'fair comment' il-kumment isir semplici invettiva jew abbuz²⁹.** Id-decizjoni fl-ismijiet "Reginald Miller -vs- Joseph J. Scorey", Appell Kriminali, 26 ta' April 1948 toffri spjega dettaljata ta' x'jikkostitwixxi "comment" u x'jikkostitwixxi "fair". Jinghad li "the criticism is not "fair" if it is such as any fair man, however exaggerated or obstinate his views, would not have written that criticism". Ghalhekk id-difiza tal-kumment gust taqa' comb ghax kif inhu logiku "the defence of fair comment does not extend to cover misstatement of facts, however 'bona fide'" (Vol XXX III pIV p800; Vol XLIII pIV p1126; Vol XLII pIV p1470; Vol XLIV pIV p874).

Il-Qorti tagħmel referenza wkoll għad-decizjoni tal-Qorti Ewropeja dwar id-Drittijiet tal-Bniedem fl-ismijiet **Lindon, Otchakovsku and July v. France**, Appl. Nos. 21279/02 u 3644/02 mogħtija fit-22 ta' Ottubru 2007, fejn il-Qorti bla tlaqliq ta' xejn iddikjarat li persuna politika, anke jekk kontroversjali u *of an extremist position in the political spectrum*, għandha ukoll tgawdi mill-protezzjoni tal-Konvenzjoni fir-rigward tal-malafama u libel. In effetti dik il-Qorti għamlet is-segwenti osservazzjoni: *the Court nevertheless considers that in the present case the Court of Appeal made a reasonable assessment of the facts in finding that to liken an individual, though he be a politician, to the "chief of a gang of killers", to assert that a murder, even one committed by a fictional character, was "advocated" by him, and to describe him as a "vampire who thrives on the bitterness of his electorate, but sometimes also on their blood", oversteps the permissible limits in such matters*. *The Court moreover considers that, regardless of the forcefulness of political struggles, it is legitimate to try to ensure that they abide by a minimum degree of moderation and propriety, especially as the reputation of a politician, even a controversial one, must benefit from the protection afforded by the Convention. The Court will further have regard to the nature of the remarks made, in particular to the underlying intention to stigmatise the other side, and to the fact that their content is such as to stir up violence and hatred, thus going beyond what is tolerable in political debate, even in respect of a figure who occupies an extremist position in the political spectrum.*

Il-Qorti ma tistax tonqos milli tosserva li dan il-paragun ma sarx semplicelement għal fini ta' paragun izda sar bl-intenzjoni specifika li jinxtehet dawl ikrah fuq l-attur li qed jigi pparagunat ma' persuna ferm kontroversjali fis-socjetà Maltija u li diversi drabi sab ruhhu fċċentru ta' l-attenzjoni minhabba mibegħda razzjali u li, kuntrarjament

F'dan ir-rigward il-Qorti tagħmel referenza wkoll għas-silta mill-artikolu intitolat "Black shirts and blacker hearts" ipubblikat fil-harga ta' The Malta Independent on Sunday tal-21 ta' Mejju 2006 fejn il-konvenuta qalet: *Karmenu Mifsud Bonnici did not shoot Raymond Caruana dead or ransack the halls of justice and the seat of the archbishop, but he failed to control the violence of the mob. These are things we lived through – bombs, deaths, shootings, ransacking, threats, fear – so why are we now behaving as though it is out of the question for rabid followers of an extremist organization to set fire to the property of those who criticize them? We, more than others, should know that it is not just entirely possible, but that it is almost certainly the correct explanation of what has been happening. After all we have lived through this kind of thing already.*

B'din l-affermazzjoni l-konvenuta effettivament qed takkuza lill-attur li wettaq reat kriminali peress illi ai termini tal-Kodici Kriminali li persuna xxewwex lil haddiehor biex iwettaq reat kriminali jikkostitwixxi reat kriminali fih innifsu hekk kif provdut fl-Artikoli 42(e), 68 u 82A tal-Kap.9 ta' l-imsemmi Kodici. F'materja ta' libel u malafama huwa principju stabbilit fis-sistema guridika nostrali li l-assocazzjoni ta' persuna ma' attivitajiet kriminali jew addirittura l-addebitu ta' attività jew reat kriminali mingħajr il-bazi ta' ebda prova izda biss imsejsa fuq ragunijiet politici tammonta għal malafama u dan kif jirrizulta mis-sentenzi fl-ismijiet **L-Avukat Dottor Louis Galea v. Frans Ghirxi bhala editur tal-gurnal "L-Orizzont", Citaz. Nru. 947/99** deciza mill-Prim' Awla tal-Qorti Civili fit-3 ta' Mejju 2002 u **Daphne Caruana Galizia v. Joseph Muscat et, Citaz. Huwa veru li fiz-zmien in kiwstjoni kien hemm diversi atti ta' vjolenza fil-konfront ta' persuni li kienu jahdmu mar-refugjati u fil-konfront ta' persuni li kienu jikkritikaw lil min kien fermament kontra l-immigrazzjoni, fosthom il-konvenuta, u allura wieħed jista' jikkonkludi li dawn kienu atti relatati mal-kwistjoni ta' l-immigrazzjoni li dak iz-zmien kienet kwistjoni tahraq hafna hawn Malta. Izda, il-konvenuta ma ressqitx provi li sodisfacientement jorbtu

lill-attur jew dak dikjarat mill-attur dwar il-kwistjoni ta' l-immigrazzjoni ma' dawn l-atti partikolarment meta l-attur, kuntrarjament ghal persuni ohra³¹, kien pubblikament ikkundanna dawn l-atti hekk kif jirrizulta mill-artikolu li deher fuq timesofmalta.com fit-18 ta' Mejju 2006, kwindi qabel ma' gew ipubblikati l-artikoli mertu tal-proceduri odjerni, esebit mill-konvenuta stess, intitolat *ANR launches campaign against illegal immigration*, esebit mill-konvenuta stess, fejn gie rappurtat illi ANR had heavily condemned the recent spate of arson attacks, which Mr. Degiorgio described as "terrorist acts", expressing the fear that they could escalate and questioning where they would stop. Those who committed such crimes needed to feel totally isolated and their condemnation had to come from every corner, he said. Apart from damaging democracy, such acts were also working against ANR, which some people were suspecting were behind the attacks. Echoing the Police Commissioner's words, he said it was dangerous to point fingers, adding that those who were involved in human trafficking could also be suspects. Mr. Degiorgio disassociated ANR completely from extreme right wingers and insisted that none of its members had been approached by the police. Il-Qorti mhux se tidhol fil-mertu dwar jekk l-attur ikkundannax l-atti ta' vjolenza fuq program televiziv jew le, izda mill-artikolu appena citat jidher car li huwa apertament u pubblikament ikkundanna tali atti, kundanna li l-konvenuta ghogobha tinjora ghal kollox.

Fl-artikolu intitolat "Martin and friends make the news" ippubblikat fil-harga ta' The Malta Independent on Sunday tat-18 ta' Gunju 2006 il-konvenuta stqarret illi: *This is how he was reported in the IHT: "We are a close-knit society and the migrants are, destroying our culture, Degiorgio said from his car, with DVX – the Latin letters for 'Duce', the title of the Italian fascist dictator Benito Mussolini – written on his licence-plate, Degiorgio said he would warn that the Africans risked turning Malta into the toilet of the Mediterranean. 'Islam took Malta by force, and now the Africans are invading us silently,' he said".*

"CGD5"³³ ta' l-artikolu in kwistjoni u fejn il-konvenuta tallega li l-attur qal *the Africans risked turning Malta into the toilet of the Mediterranean*, ma jirrizultax li gie riportat li l-attur effettivament qal hekk.
