Rat ir-rikors promotur ippresentat fil-25 ta' Awissu 2009, fejn ir-rikorrenti talbu lill-Qorti tikkundanna lill-intimat ihallas danni talli, permezz ta' pubblikazzjoni ta' Press Release miktuba mill-intimat, intitolat "*Birdlife Malta infiltrate Education Department*", immalafamaw lill-atturi u jesponuhom ghad-disprezz u ghar-redikolu tal-pubbliku.

Rat il-Press Release mahruqa fl-10 ta' Gunju 2009, mahruqa mill-FKNK, ossija Federazzjoni Kaccaturi u Nassaba Konservazzjonisti u iffirmata b'isem l-intimat, bhala PRO ta' l-istess Ghaqda.

Rat ir-risposta ta' l-intimat ippresentata fl-10 ta' Mejju 2010 fejn eccepixxa, preliminarjament, illi l-Press Release inharget mill-Federazzjoni Kaccaturi u Nassaba Konservazzjonisti, li taghha l-intimat huma l-Publi Relations Officer, izda huwa ma ghandhux rappresantanza guridika taghha u ghalhekk ghandu jigi liberat mill-osservanza tal-gudizzju. Eccepixxa wkoll, fil-meritu, illi dak illi hemm miktub huwa essenzjalment "fair comment".

Rat ix-xhieda ta' **Joseph Mangion** moghtija fid 9 ta' Frar 2011 u rat id-dokumentazzjoni minnu esebita.

Rat illi bejn l-14 ta' Gunju u it 28 ta' Novembru 2011 saru erbgha seduti fejn il-Qorti giet infurmata illi l-partijiet kienu qed jippruvaw jittransigu.

Rat illi fis 16 ta' Jannar 2012, transazzjoni ma ntlahqietx u ghalhekk tkomplew il-provi, fejn il-Qorti semghet lill **Desiree Falzon**.

“ Birdlife Malta Infiltrate Education Department

It is with deep remorse and resentment that the Federation for Hunting and Conservation – Malta (FKNK) notes the Department of Education's issue of calls for applications for the posts of Birdlife Malta teachers for both primary and secondary level education.

Birdlife is renowned for its anti-hunting lobby and more so for its gradula 'brain washing' of our children through the suppluy of misinterpreted and misrepresented material facts, thus depriving them of aa fair and unbiased platform about what the environment and conservation should all be about.

The FKNK seriously deplores this action and feels that it and its members' children are bring gravely discriminated against. Whilst the applications are publicly issued, both the present Minister for Education and her predecesor have, to date, refused to meet officials of the FKNK in order to be in a position to offer a lever educational platform for our children.

One again the Federation formally requests an urgent meeting with Minister Cristina in order to discuss these important issues that concern our children's education.

Jirrizulta illi dina l-istqarrija inharget mill-Federazzjoni Kaccaturi u Nassaba Konservazzjonisti (FKNK) rizultat ta' *'Letter Circular'* mahruqa mid-Direttorat ghal Servizzi Edukattivi datata 26 ta' Mejju 2009 intitolta *"Applications for the Posts of teachers for Birdline in Secondary Schools in the Peripatetic Service (Malta & Gozo)* u cirkolata ma' Kapjijiet ta' l-iskejjel kollha tal-Gvern. (fol 82)

Jirrizulta illi tali sejha kienet intiza sabiex ikun hemm ghalliema ma' l-iskejjel kollha sekondarji tal-Gvern, illi jkollhom, bhala xoghol is-segwent:

"Selected candidates will be expected to:

- Visit secondary schools giving talks on Birdlife Migration Project*
- Co-ordinate follow-up activities*
- Liason with Birdlife Office*
- Encourage bird watching"*

Jirrizulta illi l-FKNK hassitha urtata minn tali sejha mid-Dipartiment tal-Edukazzjoni u ghalhekk harget tali stqarrija fejn wriet it-thassib serju taghha kif ukoll insistiet illi, ghalkemm kienu ilhom jitolbu laqghat mal-Minister tal-Edukazzjoni, tali laqghat baqghu qatt ma saru.

Jirrizulta, finalment, illi fl-10 ta' Ottubru 2009, il-FKNK iltaqghat mal-Ministru tal-Edukazzjoni u inharget stqarrija illi kienet tghid is-segwent:

A delegation from the Federation for Hunting & Conservation – Malta (FKNK) called on the Minister for Education, Culture, Youth and Sport Dolores Cristina at her office in santa Venera.

The FKNK officials voiced their concern regarding various complaints made by several members of the Federation in that some teachers, especially in primary schools but also in higher levels, are passing anti-hunting/trapping remarks During lessons which in turn influence the pupils to turn against their hunter/trapper parents.

The Minister, who was accompanied by Dr Grace Grima, Director General for Quality and Standards in Educations, who is also responsible for the curriculum, emphasised that teachers should stick to the lesson curriculum and refrain from making anti-hunting/trapping remarks to their purpils during lesssons.

The FKNK agreed to supply the Ministry with a 'Teachers' Pack' expaining the conservation efforts of hunters and trappers in the natural enviornment. The FKNK officials further explained that upon the Ministry's approval, the Pack can be explained in more detail to teachers at seminars that can be organised for such purpose.

Jirrizulta illi r-rikorrenti, bhala President u Segretarja tal-Birdlife Malta rispettivament, hassuhom malafamati bl-allegazzjonijiet illi kienu saru fil-konfront tal-Birdlife. Huwa stqarrew illi ma kienx minnu illi l-Birdlife kienet 'infiltrat' fid-Dipartiment tal-Edukazzjoni, izda hija kienet biss ippresentat progett lid-Dipartiment tal-Edukazzjoni, illi kien intlaqa' mill-istess Dipartiment, wara

liema, l-istess Dipartiment hareg sejha għall għalliema interessati abbazi tal-progett presentat mill-Birdlife, u għadda biex għazel l-għalliema sabiex imexu dana il-progett.

Ir-rikorrenti hassuhom malafamati wkoll għall fatt illi ma kienx minnu illi huma kienu jippromuovu messagg kontra il-kacca, u dana peress illi kienu qed jinsistu illi huma jippromuovu l-messagg kontra l-kacca illegali, u mhux kontra l-kacca legali, u dana fost hafna affarjiet oħra illi huma jippromuovu favur l-ambjent u juzaw dievrsi mezzi, fosthom il-ktejjeb ‘Dimja Wahda’, illi jittqassam fl-iskejjel.

Ir-rikorrenti, kif ukoll persuni oħra involuti fil-programm edukattiv tal-Birdlife Malta, jikkontendu finalment, illi ma huwiex minnu illi huma jagħtu informazzjoni qarrieqa u misinterpretata, kif qed jalligaw l-intimati, u, fil-kaz ta’ Nicholette Falzon, illi ma hijex parti mill-kawza, dina thossha malafamata bl-akkuza illi bhala għalliema hi, flimkien ma’ l-għalliema sekondata mid-Dipartiment tal-Edukazzjoni għall progett tagħhom fil-primarji, b’xi mod jagħmlu ‘brain washing’ tat-tfal kontra l-kacca.

L-intimat, da parte tieghu, laqa’ għal dak lillu imputat billi insista, l-ewwel u qabel kollox, illi huwa kien kiteb l-istqarrija meritu tal-kawza odjerna għan-nom u in rappresentanta tal-Federazzjoni Kaccaturi u Nassaba Konservazzjonisti, u għalhekk ma kellux jitharrek fil-kwalita’ personali tieghu, kif għamlu ir-rikorrenti. Apparti minn hekk, fuq il-meritu, l-intimat sahaq illi dak illi nkiteb kien ‘*fair comment*’ fuq fatti sostanzjalment veri.

Il-Qorti, l-ewwel u qabel kollox, ma tistax ma tesprimix d-disappunt tagħha għal fatt illi dawna z-zewgt għaqdiet ambjentalisti ewlenin f’Malta, minhabba fit-twemmin tagħhom w il-posizzjonijiet opposti tagħhom fuq kwistjonijiet ambejntalisti, ma kienux kapaci illi jirrikonciljaw id-differenzi tagħhom bi transazzjoni bejniethom, għalkemm dina l-Qorti tat lill-partijiet varji opportunitajiet sabiex jaslu għal tali soluzzjoni.

Kunsidrat dan, il-Qorti tosserva wkoll illi l-battalja tal-hsibijiet bejn dawk hemm imsejha ‘ambjentalisti’ u dawn imsejha ‘kaccaturi’ hija battalja illi certament ilha tesisti decenni shah u għad tibqa tesisti sakemm il-bniedem ikun għadu liberu illi jagħzel u jgestixxi d-delizju tieghu liberament, liema battalja tispicca meta tali liberta’ titnehha, fatt illi, madanakollu, il-Qorti tifhem illi hadd ma jawspika illi qatt tigrigi għax inkella l-libertajiet illi ahna tant nghozzu ikunu gew mnaffra, jekk mhux imehhija għal kollox.

Dana qieghed jinghad għax, fil-kaz odjern, għandna zewgt entitajiet illi jhaddnu veduti diametrikament opposti fejn tidhol il-kacca ta’ għasafar filwaqt illi t-tnejn finalment ihaddnu l-istess għan ewlieni, ossija dik illi jipproteggi l-interessi tal-membri tieghu u tat-twemmin ta’ l-istess membri.

L-ewwel difiza mressqa mill-intimat quddiem dina l-Qorti kienet illi huwa qatt ma messu tharrek fil-kwalita’ personali tieghu, izda messa tharrek il-Federazzjoni Kaccaturi u Nassaba

Konservazzjonisti ili taghha l-intimat kien il-Public Relations Offices meta harget il-Pree Release meritu tal-kawza odjerna.

Jirrizulta fatt indisputat illi l-istqarrija illi minnha qed jilmentaw ir-rikorrenti, kienet staqrija mahruqa mill-Federazzjoni Kaccaturi u Nassaba Konservazzjonisti, illi taghha l-intimat kien il-PRO, u mhux mill-intimat personalment. Dana jirrizulta kemm mill-istqarrija stess kif ukoll mix-xhieda u dokumentazzjoni ipprezentata quddiem dina l-Qorti, u ghalhekk, l-ewwel difiza kif imsesja mill-intimat tirrizulta, minnha innifisha, ippruvata.

Il-Qorti tista facilment tieqaf hawn, madanakollu, kieku taghmel hekk tkun qieghda tabdika mill-obbligu taghha illi huma biss taghmel gustizzja izda, aktar u aktar, illi tidher li qed taghmel gustizzja.

Ghalhekk, ikun opportun illi wiehed jidhol ukoll fil-meritu tal-kaz.

Ir-rikorrenti jilmentaw, principalment, minn tlett aspetti tal-istqarrija – il-fatt illi fl-istqarrija jinghad illi l-Birdlife “infiltrat” id-Dipartiment tal-Edukazzjoni, il-fatt illi l-Birdlife qieghda timmanipula u timmisrappresenta l-informazzjoni w il-fatt illi l-Birdlife qieghda taghmel “brain washing” tat-tfal.

L-intimat, dan parte tieghu, jishaq illi l-fatt illi d-Dipartiment tal-Edukazzjoni irrikonoxxa illi kellu jkun hemm ghalliema ufficjali tal-Birdlife fl-iskejjel tal-Gvern kienet prova sufficjenti illi attwalment il-Birdlife kienet dahhlet it-twemmin taghha fid-Dipartiment tal-Edukazzjoni. Dwar manipulazzjoni ta’ l-informazzjoni kif ukoll ‘brain washing’ tat-tfal, l-intimat jaghmel referenza ghall ktejjeb tal-Birdlife, mahrug prejodikament u mqassam fl-iskejjel tal-Gvern, intitolat ‘Dinja Wahda’ u jindika illi, fejn tidhol il-kacca, l-informazzjoni moghtija lill-qarrejja dwar il-kacca huma kollha negattivi u intizi sabiex jitfghu lill-kaccaturi f’ dell ikrah.

Il-Qorti tosserva illi harsa lejn dana il-ktejjeb, illi jipprovdi hafna ifnormazzjoni siewja u interessanti dwar l-ambjent u l-protezzjoni taghha, imkien ma jghaddi xi tipt a’ kumment favur il-kacca, izda, tul il-ktejjeb kollu, hlief referenzi ghall kacca illegali u masakri ma ssirx.

Il-Qorti tosserva illi ghalkemm tali attivitajiet illegali ghandhom jigu kkundannati u skoraggiti fit-tfal minn eta tenera, certament hemm aspett legali tal-kacca illi tali ktejjeb imkien ma jidher illi jikkontempla, u ghalhekk l-intimat u il-Federazzjoni huma sostanzjalment korretti meta jghidu illi tali ktejjeb jaghti informazzjoni negattiva dwar il-kacca.

Huwa fatt maghruf illi l-kacca illegali hija hazina u ghandha tigi kkastigata kif mishoqq – madanakollu, hemm ukoll il-kacca legali, li ghandu jigi protett ukoll u muri lill-kullhadd, partikolarment it-tfal zghar, sabiex it-tfal jinghataw stampa kompleta tal-kacca – sfortunatament, il-ktejjeb informattiv maghmul mill-Birdlife jonqos milli jilhaq tali bilanc.

Id-difiza mressqa mill-intimata hija, principalment, dik ta’ ‘*fair comment*’, stante illi sahqet illi l-pubblikazzjoni hija bbazata fuq fatti sostanzjalment korretti..

Kif qalet il-Grand Chamber tal-Qorti Ewropea ghad-Drittijiet tal-Bniedem fl-ismijet **Axel Springer AG vs Germany** deciza fis-7 ta’ Frar 2012, intqal is-segwent:

78. *Freedom of expression constitutes one of the essential foundations of a democratic society and one of the basic conditions for its progress and for each individual's self-fulfilment. Subject to paragraph 2 of Article 10, it is applicable not only to "information" or "ideas" that are favourably received or regarded as inoffensive or as a matter of indifference, but also to those that offend, shock or disturb. Such are the demands of pluralism, tolerance and broadmindedness without which there is no "democratic society". As set forth in Article 10, freedom of expression is subject to exceptions, which must, however, be construed strictly, and the need for any restrictions must be established convincingly* (see, among other authorities, *Handyside v. the United Kingdom*, 7 December 1976, § 49, Series A no. 24; *Editions Plon v. France*, no. 58148/00, § 42, ECHR 2004-IV; and *Lindon, Otchakovsky-Laurens and July v. France [GC]*, nos. 21279/02 and 36448/02, § 45, ECHR 2007-IV).

Kif jinghad f'Gatley on Libel and Slander :

To succeed in a defence of fair comment the defendant must show that the words are comment, and not a statement of fact. He must also show that there is a basis of fact for the comment, contained or referred to in the matter complained of. Finally, he must show that the comment is on a matter of public interest, one which has expressly or implicitly put before the public for judgment or is otherwise a matter with which the public has a legitimate concern. If, however, the plaintiff can show that the comment was not made honestly or was actuated by malice, he will defeat the plea.

Kif inghad minn Lord Justice Scott fil- kawza **Lyon v. Daily Telegraph:**

The right of fair comment is one of the fundamental rights of free speech and writing which are so dear to the British nation, and it is of vital importance to the rule of law on which we depend for our personal freedom.

Ikkunsidrat

Jirrizulta, mill-provi prodotti, illi dak ilmentat mill-Federazzjoni tal-Kaccaturi u Nassaba Konservazzjoniet kien wiehed ibbazat fuq fatti sostanzjalment veri, stante illi kien minnu illi l-Birdlife kienu gew rikonoxxjuti mid-Dipartiment tal-Edukazzjoni sabiex jiehdu hsieb jwasslu l-messagg taghhom lit-tfal ta' l-iskejjel tal-Gvern, kif ukoll kien minnu illi fil-ktejjeb taghhom, ma kien hemm ebda referenza ghal kacca legali u l-beneficcji taghha, izda kien hemm biss referenzi ghal kacca illegali u l-kosnegwenzi koroh taghha.

Dana kollu jindika illi l-kumment illi kienet qieghda taghmel il-Federazzjoni Kaccaturi u Nassaba Konservazzjoni kien wiehed sostanzjalment korrett u ghalhekk l-ilment tar-rikorrenti ma jistax jintlaqa.
