vs

Peter Jozsef Zoltan

The Court,

Having seen the charges against **Peter Jozsef Zoltan** holder of Identity Card number 78193(A).

Charged with having on the 2nd of March 2016 at around 21:45hrs in Patri Felic Street in St. Paul's Bay caused bodily harm to PC 834 Y. Vella, while in the act of discharging his duty or because of his having discharged such duty, or with intent to intimidate or unduly influence him in the discharge of such duty.

And with having on the same date, place, time and circumstances mentioned above attempted to drive or was in charge of motor vehicle or other vehicle bearing registration number EBX-373 on a road or other

public place after consuming so much alcohol that the proportion of it in his breath, blood or urine exceeded the prescribed limit.

And with having on the same date, place, time and circumstances mentioned above driven a motor vehicle without a driving license.

And with having on the same date, place, time and circumstances mentioned above driven a motor vehicle without a valid insurance policy in respect of third party risks.

And with having on the same date, place, time and circumstances mentioned above whilst being in a public place or place open to the public, been drunk and incapable of taking care of himself.

And with having on the same date, place, time and circumstances mentioned above refused to obey legitimate order by public officers.

Having seen that the defendant admitted the charges brought against him.

Having seen the acts of the proceedings.

Have heard the submissions of the parties.

Having considered

That the defendant admitted the charges brought against him; these are consequently sufficiently proven.

With regards to the penalty to be meted out the Court took into consideration the nature of the offences of which the defendant is being found guilty, his cooperation with the investigating officer, and his admission at the earliest stage of these proceedings.

Wherefore the Court, after having seen sections 95 and 338(ee)(ff) of Chapter 9 of the Laws of Malta, sections 15(1) and 15B of Chapter 65 of the Laws of Malta and section 3 of Chapter 104 of the Laws of Malta, on his admission finds defendant guilty of the charges brought against him and condemns him to six (6) months imprisonment which by application of section 28A of the said Chapter 9 are being suspended for a period of two (2) years, to a fine of eight hundred Euros (€800) and an other fine

of two thousand three hundred thirty Euros (€2,330) which are to be paid within a year. The Court is also disqualifying the defendant from having any driving license for a period of one year.

The Court explained to the defendant in ordinary language the significance of this judgement and of the consequences should he commit an other offence in the period of two years.
