Dan hu appell imressaq fid-29 ta' Ottubru, 2015, mill-perit William Lewis wara decizjoni datata 13 ta' Ottubru 2015, moghtija mill-Bord ta' Revizjoni dwar Kuntratti Pubblici (minn hawn 'l quddiem imsejjah "il-Bord") fil-kaz referenza QLC-SACE 49/15.

Dan il-kaz hu marbut mas-sejha ghall-offerti li hareg il-Kunsill Lokali Qrendi “*for the service of an architect and civil engineer*”. Ghal din is-sejha applikaw xi periti u l-kuntratt gie rakkomandat li jinghata lill-perit Anthony Bezzina ghan-nom ta’ ACB Architects. Dwar l-offerta tal-perit Lewis inghad semplicement illi “*it has not been accepted*”. L-imsemmi perit Lewis, b’ittra tad-9 ta’ Gunju, 2015, ipprezentata lis-segretarju ezekuttiv tal-Kunsill Lokali Qrendi, ressaq appell “*as per clause 12, Part 4 of SL 363.03 Local Councils (Tendering) Regulations*”. Is-segretarju ezekuttiv ghadda l-appell lill-imsemmi Bord li b’decizjoni tat-13 ta’ Ottubru, 2015, cahad l-appell ghax qies li ma kellux kompetenza jisma’ l-kaz. Id-decizjoni tal-Bord hi s-segwent:

“The Public Contracts Review Board,

- “Having established that the estimated value of the tender in caption is five thousand four hundred and eighty one euro eighty cents (€5,481.80) exclusive of VAT;
- “Having noted Regulation 21.(1) of the Public Contracts Procurement Regulations, S.L.174.04, which states that “*Where the estimated value of the public contract exceeds twelve thousand euro (€12,000) and is issued by an authority listed in Schedule 1, any tenderer or candidate concerned shall have a right to make a complaint to the Review in accordance with this regulations.*”;
- “Having considered that the estimated value of the tender is less than €12,000;

“Resolves that the objection is not according to Regulations since the right of recourse to review is restricted to tenders exceeding the €12,000 threshold and that therefore the Board cannot consider the objection any further.

In the circumstances, this Board recommends that the deposit paid by the appellant, when filing the objection, be reimbursed.”

Il-perit Lewis appella mid-decizjoni ghax isostni li ma kienx hu li ressaq l-appell tieghu quddiem il-Bord, u ghal zball tas-segretarju eżekuttiv m'ghandux ibati l-konsegwenzi hu.

Jirrizulta bhala fatt li peress li l-kuntratt in kwistjoni kellu valur ta' taht it-€12,000, l-appell mid-decizjoni tal-Kunsill kellu jitressaq mhux quddiem il-Bord, izda quddiem il-Bord tal-Appelli mwaqqaf mill-Ministru taht il-legislazzjoni sussidjarja relattiva. L-appellant perit Lewis ghamel dak li kellu jaghmel bil-ligi billi, ai termini tar-regolament 12 tal-ligi sussidjarja, ressaq l-appell *“lis-segretarju ta' dak il-Kunsill Lokali”*, u kien dmir ta' dan li jidderigi l-appell lill-bord kompetenti skont il-provvedimenti tal-istess ligi sussidjarja. Mhux kompitu ta' min irid jappella biex jara li s-segretarju tal-Kunsill iwettaq dmiru kif suppost, izda hu dmir tal-istess segretarju li jsegwi l-ligi u jidderigi l-appell quddiem il-bord kompetenti. L-appellant Lewis ghamel dak li kien mistenni minnu skont il-ligi billi ressaq l-appell, bid-depożitu relattiv, lis-segretarju tal-Kunsill Lokali Qrendi, u ghall-izball ta' dan tal-ahhar ma ghandux ibati l-appellant.

Is-sentenza li ta l-Bord fit-13 ta' Ottubru, 2015, ma tistax, pero`, tithassar ghax hi tajba fid-decizjoni taghha. Darba li l-valur tal-kuntratt kien taht it-€12,000 iddecieda sew li ma kellux kompetenza jiddeciedi fuq l-appell kif imressaq quddiemu. Darba issa li l-appell kif imressaq quddiem il-

Bord gie dikjarat irritu u null fuq bazi ta' nuqqas ta' kompetenza, is-segretarju tal-Kunsill Lokali Qrendi ghandu jirrimedja ghall-izball tieghu billi jibghat l-appell tal-perit William Lewis lill-Bord tal-Appelli kompetenti, biex l-appell jigi deciz kif trid il-ligi. L-appell tal-perit Lewis jidher li gie ipprezentat lis-segretarju tal-Kunsill fit-terminu stabbilit mil-ligi, u li jonqos issa huwa li dan iwettaq dmiru u jghaddi l-istess lill-bord vestit bil-ligi bil-kompetenza biex jisma' dak l-appell.

Ghaldaqstant, ghar-ragunijiet premessi, tiddisponi mill-appell tal-perit William Lewis billi tilqa' l-istess in parte, u filwaqt li tikkonferma d-decizjoni li ha l-Bord ta' Revizjoni dwar Kuntratti Pubblici fit-13 ta' Ottubru, 2015, tordna lill-appellat Kunsill Lokali Qrendi sabiex fi zmien gimgha millum jghaddi l-appell li ressaqlu l-perit Lewis bl-ittra tad-9 ta' Gunju, 2015, lill-Bord tal-Appelli mahtur skont il-ligi ghall-iskop indikat.

L-ispejjez marbuta ma' dan l-appell ghandhom jithallsu kollha mill-appellat Kunsill Lokali Qrendi – u dan peress li kien zball tas-segretarju tieghu li wassal ghall-vertenza.
