Rat ir-rikors promotur ippresentat fid-29 ta' Dicembru 2008 fejn ir-rikorrent talab lill-Qorti tikkundanna lill-intimat ihallas lill-attur dik is-somma li dina il-Qorti, ai termini ta' l-artikolu 28 ta' l-Att dwar l-Istampa, tiddetermina bhala danni u riparazzjoni tal-malafama li huwa sofra meta permezz ta' ittra datata 10 ta' Dicembru 2008 mibghuta u publikata skond il-ligi lil terzi, ghamilt allegazzjonijiet foloz u malafamanti fil-konfront tal-istess attur bil-ghan li tellfu jew tnaqqaslu ir-reputazzjoni tieghu, meta, fost ohrajn ghidt li huwa kien responsabbli ta' "*ksur ta' l-statut, abbuz ta' poter u atti ta' korruzzjoni*", li "*ammonti kbar ta' flus dovuti lill-MFA ... ma gewx depozitati fil-kontijiet bankarji tal-MFA*", "*abbuz ta' poter u mizapproprjazzjoni ta' fondi*" u li "*abbuza minn flus li originaw minn programmi ta' assistenza tal-UEFA*" u "*bi ksur sfaccat tar-regolamenti*" fil-kariga tieghu ta' President tal-MFA, oltre allegazzjonijiet ohra, liema allegazzjonijiet huma ghal kollox inveritjieri, malizjuzi u intizi biss biex jaghmlu hsara lill-attur.

Rat l-ittra meritu tal-kawza odjerna, indirizzata lill Joe Gauci, Segretarju Generali tal-Malta Football Association, datata **10 ta' Dicembru 2008**, esebita mir-rikorrent illi kienet tghid is-segwenti:

Akkuza ta' ksur ta' Statut, abbuz ta' poter, mizapproprjazzjoni ta' fondi u atti ta' korruzzjoni ta' Dr Joseph Mifsud, President tal-Malta Football Association.

Ghaziz Sur Gauci,

Nixtieq naghmel riferenza ghad-diskors ricenti tal-President tai-MFA. Dr. Joseph Mifsud fejn dan pubblikament ghamel appell lil kull min ghandu xi informazzjoni dwar

atti ta' korruzzjoni fil-football Malti, biex jaghmel kuragg u jressaqhom quddiem l-assocjazzjoni. Biex inkun ezatt se nikkwota d-diskors tal-President, hekk kif kien irrapurtat f'wahda mill pagni, fuq is-sit elettroniku - www.maltarightnow.com ta' nhar is-26 ta Lulju 2008, liema diskors ma saret l-ebda korrezzjoni ghalih.

Id-diskors huwa parti minn artiklu bl-isem ta' 'Diskors iebes minn Joe Mifsud. President tal MFA' u b'titlu sekondarju li jghid 'Dr. Joe Mifsud "M'hemmx hniena ma' kazi ta korruzzjoni"

"Pero ma jiswa xejn jekk inhallu d-dell tal-korruzzjoni fuq il-football Malti. Hawn wisq diskors u ghalkemm forsi mhux kollox ikun vera, il-qasba ma ccaqcaqx ta' xein. Iridu noqghodu attenti u niridu nahdmu halli d-dell tal-korruzzjoni innehhuh." Dr. Mifsud kompli b'appell dirett "Fejn hemm il-hazin irrapurtawh. Huwa d-dover taghkom. Importanti li l-football Malti jkun nadif minn kulhadd. M'hemmx hniena ma' kazi ta' korruzzjoni u kull min jzbalja jrid thallas. Il-korruzzjoni hija l-mewt tal-football Malti u ma nistghux inhallu ftit nies ikissru l-football. Ahna m'ahna se nibzghu minn hadd u intom fid-dover li tirrapurtaw kull traccia li ssiru tafu."

"Nitlob irguliya u serjeta minn kulhadd. Thallux lil min jgharraq il-loghba u lill-klabbs. Xein ma jiswa jekk ikollna il-marda tal-korruzzjoni fil-football." Dr. Mifsud tenna li dan id-diskors sar ukoll f'laqghat ohra f'setturi ohra fil-football, inkluz fil-qasam tar-referring. "se niehdu passi bkar. Min jikxef intuh immunita u ma jkunx fil-perikolu. Ahna rridu naqbd u l-brimba u a nridux niex mhux serji fil-loghba tal-football. Se ninvestigaw kull kaz, pero nikkundannaw fuq il-provi. Il-football huwa industrija f'pajjizna u mhu se nhallu lil hadd jeqirdu" temm b'lehen sod il-President tal-MFA."

Fl-ispirtu ta' dan id-diskors imqanqal tal-President, Dr. Joseph Mifsud, fil-qadi tad-doveri tieghi li nirraporta kull traccia li naf biha, nixtieq nirraporta u ngharrfek b'dan li gej:

- a. *Naghamel riferenza ghal-ittra tieghi li ggib id-data tat-22 ta Novembru, 2000 u li jien kont baghat lic- Chairman tal-Permanent Board of Inquiry tal-MFA, f'liema ittra jien kont ghamilt allegazzjonijiet serji fil-konfront tal-President tal-MFA, Dr. Joseph Mifsud, liema allegazzjonijiet kienu, fost ohrain jinkludu, ksur tal-Istatut, abbuz ta' poter u atti ta' korruzzjoni. Nikkonferma li kont ircevejt twegiba minghand l-istess bord li biha kont gej avzat li l-kaz tieghi kien se jigi mghoddi lil-Kumitat Ezekuttiv ghall-kunsiderazzjoni tieghu, u dan ghaliex, hekk kif spjegat fl-ittra li ntbaghtet b'referenza ghall-ittra tieghi, kellu jkun biss il-Kumitat Ezekuttiv li seta jirreferi l-kaz tieghi quddiem il-Permanent Board of Inquiry. Minhabba li ghadda hafna zmien u ghadni ma smajt xejn f'dan ir-rigward, nitlobok tgharrafni jekk l-ittra kienetx fil-fatt tressqet quddiem il-Kumitat Ezekuttiv tal-MFA, u jekk fil-pozittiv, nixtieqek tgharratni bid-decizjoni finali tal-Kumitat Ezekuttiv fir-rigward tal-allegazzjonijiet imressqa minni.*
- b. *Minbarra l-allegazzjonijiet imsemmija fl-ittra tieghi li ggib id-data tat 22 ta Novembru, 2000, issa irrizultatli allegazzjoni gdida dwar fatti godda ta' evidenza fir-rigward ta' ammonti kbar ta' flus dovuti lill-MFA, liema flus ma gewx depozitati fil-kontijiet bankarji tal-MFA, u ghaldaqstant inkun lest li naghti d-dettalji kollha, meta nispera li din id-darba nigi mitlub sabiex nidher quddiem il-bord.*

c. *Nixtieq ukoll inressaq kaz iehor ta' abbu ta' poter u mizappropriazzjoni ta' fondi mill-President tal-MFA, Dr. Joseph Mifsud. Matul dawn l-ahhar hames snin. Il-President Mifsud, abbuza minn flus li originaw minn programmi ta' assistenza tal-UEFA (ez. Hat-Trick Program) u li kellhom ikunu vvzati u applikati biss biex jghinu lill-klabbs Maltin itejbu l-istrutturi taghhom. Dan biex l-istess klabbs jigu konformi mar-regoli l-godda tal-UEFA dwar il-licenzjar tal-klabbs. Izda il-President, Dr. Joseph Mifsud, uza dawn il-fondi ghal skopijiet totalment differenti minn dawk stipulat miil-UEFA u dan ghad-detriment tal-klabbs Maltin. Dan l-agir abbuza kontra l-klabbs fi hdan l-MFA sar bi ksur sfaccat tar-regolamenti u it-termini hekk kif indikati mill-UEFA stess f'cirkular numru 53 li ntbaghtet ghall-attenzjoni tal-President tal MFA, fit-28 ta' Lulju, 2006, fejn hemm stipulat li l-ammont pagabbli mill-UEFA ghal kull stagun kalcistiku (approssimazzjoni ta' 300 000 CHF kull stagun) jista jintuza biss biex jghin lill-klabbs igibu l-licenzja jew biex l-istess klabbs jiffrankaw parti mill-ispejjez taghhom.*

Kopja ta' din l-ittra qieghda tintbghat direttament lic-Chairman tal-Bord ta' l-Inkjesta sabiex jinvestiga dan kollu, hekk kif stipulat skond l-Istatut tal-MFA u kif ukoll lic-Chairman tal-Bord tal-Awdituri Interni tal-MFA.

Ir-rikorrent kien ukoll Membru tal-Ezekuttiv tal-UEFA, ossija l-Ghaqda ta' Assocjazzjonijiet tal-Football ta' l-Ewropa kollha, mis-sena 1994 sas-sena 2011 kif ukoll Membru tal-Ezekuttiv tal-FIFA, ossija l-Ghaqda ta' Assocjazzjonijiet tal-Football Dinjija, mis-sena 1998 sas-sena 2000.

Jirrizulta, mill-provi prodotti, illi l-intimat, Norman Darmanin Demajo, kien Tezorer tal-Malta Football Association mis-sena 1992 sas-sena 2000, meta huwa rrizenja minn tali kariga. Sussegwentement, fis-sena 2010 huwa gie elett bhala President tal-Malta Football Association, kariga illi huwa ghad ghandu sal-gurnata ta' illum.

Jirrizulta illi fit-13 ta' Novembru 2008, l-intimat kien kiteb lir-rikorrent, wara kummenti illi kienu saru fil-konfront tieghu fil-pubbliku mir-rikorrent, fejn l-intimat qal is-segwenti (Dok NDD1 – Fol 60):

Dr Mifsud,

Naghamel riferenza ghall-laqgha tal-Kunsill tal-MFA ta' nhar il-Hamis, 2 t'Ottubru, 2008 u ghall-intervista tieghek fuq il-programm televiziv REPLAY li xxandar fuq NET TV nhar id-19 ta' Ottubru 2008, fejn fiz-zewgt okkazzjonijiet inti ghogbok tattakka lili personali b'mnuri ta' allegazzjonijiet infondati. Permezz ta' dawn l-allegazzjonijiet, ippruvajt taghti l-impressjoni (hekk kif ghamilt kemm il-darba matul dawn l-ahhar tmien snin) li jiena bniedem hati li fil-passat ghamilt hsara lill-MFA u li ghandi xi agenda personal li tmur kontra l-interessi tal-futbol Malti.

“Dan (b'referenza ghal Norman Darmanin Demajo) ghamel hsara lill-MFA u ma jixraqlu qatt li jkun President tal-MFA”, silta mehuda minn diskors tieghek waqt intervista mxandra mill-programm REPLAY fuq NET TV tad-19 t'Ottubru, 2008.

Kif inti taf sew, minn meta spiccajt mill-kariga li kont nokkupa bhala Tezorer tal-MFA jien dejjem imxejt bl-attenzjoni kif nitkellem fir-rigward tieghek bhala President tal-MFA u dan ghaliex jiena kont u ghadni tal-fehma li ma jkunx ghall-gid tal-futbol Malti kieku kellna noqghodu nifthu l-kotba tal-passat. Tant hu hekk li waqt il-kampanja tieghi ghall-elezzjoni ghall-Presidenza tal-MFA ta' ftit xhur ilu, jien insistejt ma daww kollha li kienu jiffurmaw parti mit-tim tieghi biex niffokaw biss fuq il-futur tal-assocjazzjoni u dak li ahna xtaqna nwettqu skond il-programm taghna. Din id-decizjoni min-naha taghna giet irrispettata sa l-ahhar minkejja l-fatt li ftit jiem biss qabel l-elezzjoni int ghogbok tmur fuq il-programm MFA Magazine, program televiziv propjeta tal-MFA u attakkajt lili u l-programm elettorali li jien kont qieghed nipprezenta ghall-elezzjoni. Int kont sibt bizzejjed hin biex tipprova titfa' dell ikrah fuqi personali u fuq il-karattru tieghi u dan b'insinwazzjonijiet infondati u gideb sfaccat. Infakkrek ukoll li jien qatt ma nghatajt l-opportunita' sabiex fuq l-istess program televiziv (MFA Magazine) inkun nista' nirrispondi ghad-dikjarazzjonijiet li gew imlissna mirmek u ghall-allegazzjonijiet bla bazi li ghamilt fuqi.

Intant ftit tal-gimghat ilu cempilli s-Sur Mark Attard, gurnalist sportiv lokali u qalli li xtaq jintervistani u jien accettajt din l-istedina tieghu. Jidher li l-intervista nizlet tajjed mall-pubbliku sportiv u dan ghaliex wasluli hafna messaggi minn nies genwini li xtaqu jifirhuli ghall-kummenti tieghi. Izda milli jidher, dan l-istess artiklu ma niziex tajjed mieghek u int hassejt li ghandek taghmel riferenza ghalih fil-laqgha tal-Kunsill tal-MFA

ta' nhar il-Hamis, 2 t'Ottubru u ghaldaqstant hadt l-opportunita' biex terga tattakkani personali u ghal darb'ohra tipprova titfa' dell ikrah fuqi. Dan l-agir abbużiv min-naha tieghek kompli fuq il-program REPLAY fejn int komplejt tigdeb fuq il-passat u tiwinta dwar skopijiet ulterjuri min-naha tieghi u dan biex tipprova tghatti dak kollu li huwa fatti u li kien sehh f' dak minnek l-MFA. il-konfoffi, tat-tixhim, tal-gideb, tal-ksur sfaccat tal-istatut tal-MFA, tal-iffirmar wahdek ta' kuntratti sigrieti u t-trasferiment ta' flus f' kont bankarju mhux f'isem l-MFA.

Qiegħed nissuspetta li s-silenzju tieghi f' dawn l-ahhar snin seta' gie nterpretat minnhekk bhala sinjal ta' djuġġa jew bhala forma ta' ammissjoni min-naha tieghi fir-rigward ta' l-allegazzjonijiet li int jghogbok tagħmel fir-rigward tieghi. Dan generalment jgri, jew fil- Kunsill tal-MFA fejn jien ma nkunx prezenti biex niddefendi ruhi, jew waqt il-program televiziv tal-MFA fejn kollox huwa kkontrollat minnhekk u aktar minnhekk fejn jien qatt gejt mistieden nattendu biex ningħata l-opportunita' nirrispondik. Jekk dan is-suspett tieghi huwa minnħu, nixtieq inserrahlek rasek li dan mhux il-kaz u li jien dejjem lest, meta trid u fejn trid, li nikkonfrontak fil-pubbliku biex niddiskutu dwar dawk l-allegazzjonijiet li int, sal gurnata ta' llum għadek tagħmel fuqi minn wara dahri.

Fil-fatt, ir-raguni principali ta' dina l-ittra hija sabiex ninfurmak li mhiniex bi hsiebni noqgħod sieket aktar għall-ebda allegazzjoni ohra min-naha tieghek fil-konfront tieghi.

Dwar l-allegazzjonijiet tieghek li jien għamilt hsara lill-MFA, qiegħed ngħarrfek sabiex jew tirtirhom (permezz ta' stqarrija ufficjali u pubblika), jew tissostanzjom, jew se jkolli nieħu dawk il-passi kollħa li jidhirli huma neccessarji biex nissalvagwardja l-verita.

Ngħarrfek, biex mil-lum 'il quddiem toqgħod attent hafna x'tgħid u thares kif timxi fil-konfront tieghi. fl-messagg tieghi huwa car hafna u l-pozizzjoni tieghi mill-llum 'il quddiem ma thallilek l-ebda lok għal misinterpretazzjoni. Mhiniex lest li noqgħod aktar sieket u nħalli bniedem bhalek jipprova jiffa' xi dell ta' dubju fuq il-karattru u l-integrita tieghi. II- hmieg tieghek zommu għalik!

Fil-program REPLAY tad-19 t'Ottubru, 2008, meta gejt mistoqsi għaliex m'għamilt libell lil dawk in-nies kollħa li hamgulek ismek u għamlulek malafama fil-pubblikazzjonijiet miktubħa minnħom, int irrispondejt li minħabba l-fatt li ssiefer hafna tibza' li jagħti l-kaz li meta jkollok il-kawza ta' libell, il-kaz jista' jaqa' jekk tkun imsiefer u għalhekk ma jkollokx l-opportunita' tiddefendi ruhhek. Jien kont nahseb li tiddefendi l-unur u l-integrita tieghek huwa hafna aktar importanti minn xi safra.

Għalhekk fl-interess tal-Fair Play nixtieq inserrahlek rasek li f'kaz li joghgbok tghamill libell, jien lest li nagħmel arrangament mieghek li jizgura li jkollok ic-cans kollu meħtiej sabiex tiddefendi ruhhek u dan mingħajr il-biza' li jaqa' l-kaz, f'kaz li tinzerta barra l-pajjiz.

Jirrizulta illi sussegwentement, fl-10 ta' Dicembru 2008, l-intimat bagħat l-Ittra lis-Segretarju Generali tal-MFA, fuq ġia riprodott, liema Ittra giet diskussa fil-laqgħa tal-Ezekuttiv tal-MFA tal-15 ta' Dicembru 2008, fejn gie rrapporta hekk fil-minuti ta' l-istess laqgħa (fol 374 – Avv 8/2009):

Inqrat ittra mibghuta mis-sur Norman Darmanin Demajo, ex Tezorer tal-MFA, fejn jissemew diversi allegazzjonijiet fosthom li l-President huwa responsabbli ghal mizapproprjazzjoni ta' fondi tal-MFA.

Il-President qara wkoll ittra li s-sur Darmanin Demajo kien baghatlu d-dar xi gimghat ilu.

Inqara wkoll artiklu li deher fil-harga tal-gurnal "Ilum" tal-Hadd 14 ta' Dicembru 2008. (meritu tal-kawza 8/2009)

Il-President qal li s-sur Darmanin Demajo kien qed jiwinta u jigdeb. Huwa kien iddecieda li jaghmel libell lis-sur Darmanin Demajo, lis-sur Mark Attard, il-gurnalist li kiteb l-artiklu msemmi kif ukoll kontra l-editur ta' "Ilum".

Il-President tenna li l-finanzi tal-MFA huwa awditjati minn awditur professjonali li qatt ma rrimarka kien hemm xi nuqqas bhal dak li gie allegat.

During the weeks and months before the decision in July 2000, there was great hectic in the German camp. The delegation around Beckenbauer and his second-in command Fedor Radmann was trying to commit the shaky candidates in the FIFA executive committee to Germany as the venue. Even the Federal Chancellor Gerhard Schroder was soliciting votes for Germany amongst foreign statesmen.

In spite of all efforts, a majority for Germany was not in sight. Four weeks before the vote in Zurich, eight to nine votes for German at the most were considered as sure. The main competitor, South Africa, could hope for twelve supporters in the highest FIFA body.

It appears that in this desperate situation for Germany the duo Radmann/Netzer became active at the beginning of June 2000. At that time the former football professional Gunter Netzer was director of the Zurich agency CWL, which sold broadcasting rights for football matches to TV stations. The company formed part of the empire of Leo Kirch. And the latter owned the TV rights for the football World Cup 2006.

On 6 June Kirch law firm in Munich wrote a letter to Dieter Hahn ("personal/confidential), the executive manager of the big Leo Kirch.

In the letter a lawyer of the firm summarized the content of a conversation which he had in the morning with Fedor Radmann, the assistant of World Cup canvasser Beckenbauer.

The background of the conversation documented in the letter were obviously contracts of the Netzer-company CWL with football associations or their officials in Malta, Thailand, Trinidad and with a club in Tunis.

The national teams of these countries and the Tunisian club were to play friendly games with FC Bayern Munich; CWL acquired the TV rights for these matches from the foreign partners and paid accordingly. As a rule about 300 000 dollars per match. The conversation also concerned the further procedure in the case of Elias Zaccour. The Lebanese was given a consultancy contract of one million dollars shortly before the WC decision.

The lawyer meticulously explained for his client Hahn what was according to Radmann the state of negotiations with the corresponding contact persons.

For "Dr. Mifsud/Malta" the contract was already signed, "payment has to be effected on a trust account.

For "Mr. Chiboub (Tunisia)" the contract still had to be signed by Netzer. "The amount of US \$ 300 000 is then payable within 14 days aft Gunter Netzer's signature."

The summary is similarly concise in connection with the other two cases. "Mr. Makudi (Thailand)" is to be paid as quickly as possible. "The match has already taken place." And for "Mr. Jack Warner (Trinidad) "payment" was also to be effected on "a trust account". "I shall discuss the details with Gunter Netzer."

This sounds cryptic, but when one looks at it closer there is a bomb hidden in the letter of the Kirch attorney. Three of the four contact persons mentioned in the lawyer's letter are members of the FIFA executive committee of 24 people, the very body which was to vote four weeks later about the venue of the WC 2006.

What is even more striking: With the associations of the FIFA heads Joseph Mifsud (Malta) and Worawi (Thailand) two organizations which are considered as shaky candidates are given Kirch TV rights payments.

Worawi Makudi was considered as the king-maker before the vote, because he had not committed himself to any candidate before the vote. The Brazilians wooed him strongly. Nelson Mandela, South Africa's national hero, tried shortly before the vote by telephone to draw the King of Thailand into the camp of the South Africans, but in vain. Makudi most probably voted for Germany in the secret ballot.

Joseph Mifsud was not considered exactly as a friend of the Germans; he was to vacate his FIFA post for the DFB vice president Ger Mayer-Vorfelder. Here amends probably had to be made. It seems with success.

The names of the other gentlemen on the list are not less illustrious:

Slim Chiboub is not only the president of the Tunisian record champion L'Esperance Tunis, but also the son-in-law of President Ben one expect him to influence the Tunisian FIFA elector Slim Aloulou, who was considered a supporter of South Africa's candidature?

Interviews

On Thursday, 18 October (2012) I (Silvio Galea, Chairman tal-Board), had a short discussion with the MFA's General Secretary Mr. Joe Gauci. The reason for this interview was the fact that the letters sent to UEFA declaring that all funds were distributed to clubs and nurseries were signed by him. Mr. Gauci admitted that he signed the letter stating that all the funds were distributed. However, he said that he never saw or signed Enclosures 4 in which the funds received by the clubs and nurseries were inflated. Enclosures 4 were sent with the letter signed by Mr. Gauci but as such Enclosure 4 was never signed by him.

On Thursday 4 January, the IA interviewed Mr. Micallef and Dr. Mifsud and once again interviewed the MFA's deputy treasurer Mr. Ivan Mizzi.

Mr. Micallef stated that Dr. Mifsud as President used to announce the sum received under this scheme to the Executive Committee. He did not recall any queries by Executive Committee members regarding the sum distributed. He was involved in the workings of the coefficients and thus the sums distributed to the clubs and nurseries. However, he stated that he was not involved in the correspondence sent by MFA to UEFA in which the former declared that all funds were distributed to the clubs. This correspondence included Enclosure 4.

Dr. Mifsud acknowledged that part of the funds were not distributed to the clubs and were retained by the MFA. He stated that these funds "indirectly" went to the MFA youth teams. He said that its true that technically the MFA was not eligible to receive funds from this scheme the same applied to the Youth FA and Gozo Youth FA.

Dr. Mifsud acknowledged that the feedback sent to the UEFA including Enclosure 4 on the distribution of funds did not show the correct figures received by the clubs. He emphasized that this was done not only to conceal the funds retained by MFA but also those received by the Youth FA and Gozo Youth FA. Furthermore, he stated that he had informed informally some UEFA officials of the fact that the MFA was retaining part of these funds.

Dr. Mifsud also explained that the Finance Department, including the Treasurer Mr. Manfre, knew of the sums distributed among clubs and nurseries and also issued the cheques for the nurseries¹. However, the Finance Department was not involved in the compilation of Enclosure 4. This was compiled by Mr. Gauci and Mr. Micallef.

After these two interviews the IA talked to Mr. Ivan Mizzi who confirmed that the Finance Department was not involved in the feedback provided by the MFA to UEFA. According to him Enclosure 4 was compiled by Mr. Gauci and Mr. Micallef under the instructions of Dr. Mifsud.

On Saturday 6 January, I interviewed Mr. Manfre. He acknowledged that he knew the sums that each club and nursery received as these were give to the Finance Department to issue the necessary cheques for the nurseries. However, he stressed that he was not aware of the feedback given to UEFA by MFA including Enclosure 4.

Conclusions

From the documentation analyzed it is clear that not all the funds received from the UEFA in relation to the UEFA Solidarity Payments to Leagues were fully distributed to the eligible clubs and nurseries (almost EUR 68,000). Every year the MFA kept part of these funds for itself. This was in breach of the scheme's rules. Furthermore, the letters sent by MFA to UEFA stated that all funds were distributed when this was not the case. In the returns send by MFA to UEFA funds received by clubs and nurseries were inflated in order to show that all funds were distributed. However, it should be recalled that they were inflated not only by the funds kept by MFA but also by those distributed to the Youth FA and Gozo Youth FA. There is one important difference between the funds retained by MFA and those distributed to the two youth associations. The former

was known only to a very restricted group of high level MFA officials while the latter was known by the Executive Committee members. Thus, from the evidence analyzed the MFA reallocated these funds in the sense that it kept money it was not entitled to at the expense of its clubs and nurseries. Furthermore, the documentation sent by the MFA to UEFA was done in such a way as to conceal the funds retained by MFA, Youth FA and Gozo Youth FA. According to Dr. Mifsud, Mr. Ludovico Micallef and Mr. Joe Gauci were responsible for assisting him in the compilation of Enclosure 4 (that inflated the figures received by the clubs). This was strongly denied by Mr. Micallef who stated that at no time he was involved in the compilation of Enclosure 4.

This report is being presented to the MFA Bureau to take any remedial action it may deem fit.

Jirrizulta illi d-difiza principali ta' l-intimat kienet dik tal-fair comment.

Fil-ktieb **Gatley on Libel and Slander** (Sweet & Maxwell (London), 1981 jinghad hekk dwar in-natura ta' kumment:

A comment is a statement of opinion on facts. It is comment to say that a certain act which a man has done is disgraceful or dishonourable; it is an allegation of fact to say that he did the act so criticised. "A libellous statement of fact is not a comment or criticism on any thing". But while a comment is usually a statement of opinion as to the merits or demerits of conduct, an inference of fact may also be a comment. There are, in the cases, no clear definitions of what is comment. If a statement appears to be one of opinion or conclusion, it is capable of being comment. (para. 697, pagna 294).

L-istess **Gatley on Libel and Slander** dwar id-difiza ta' 'fair comment', imbghad, jghid dan li gej:

To succeed in a defence of fair comment the defendant must show that the words are comment, and not a statement of fact. He must also show that there is a basis of fact for the comment, contained or referred to in the matter complained of. Finally, he must show that the comment is on a matter of public interest, one which has expressly or implicitly put before the public for judgment or is otherwise a matter with which the public has a legitimate concern. If, however, the plaintiff can show that the comment was not made honestly or was actuated by malice, he will defeat the plea.

Fil-kawza **Brent Walker Group plc v Time Out Ltd** [1991] 2 QB 33 deciza mill-Qorti tal-Appell Ingliza, il-bazi tal 'fair comment' giet kunsidrata minn Bingham LJ li dwarha qal is-segwent:-

"The civil law of libel is primarily concerned to provide redress for those who are the subject of false and defamatory factual publications. Thus in the simplest case A will be

entitled to relief against B if B publishes a defamatory factual statement concerning A which B cannot show to be true. The law is not primarily concerned to provide redress for those who are the subject of disparaging expressions of opinion, and freedom of opinion is (subject to necessary restrictions) a basic democratic right. It is, however, plain that certain statements which might on their face appear to be expressions of opinion (as where, for example, a person is described as untrustworthy, unprincipled, lascivious or cruel) contain within themselves defamatory suggestions of a factual nature. Thus the law has developed the rule already mentioned that comment may only be defended as fair if it is comment on facts (meaning true facts) stated or sufficiently indicated. Failing that, the comment itself must be justified.”

Fil-kawza **Dr Louis Galea vs Etienne St John u Felix Agius** deciza mill-Prim Awla tal-Qorti Civili fit 30 ta' April 2015, intqal is-segwenti :

... dwar l-aspett tad-difiza tal-kumment ġust ilu żmien jingħad mill-Qrati tagħna li, biex id-difiza tal-kumment ġust tkun tghodd, jeħtieġ li min jistrieħ fuqha jseħħli juri li (a) l-kumment kien imsejjes fuq fatt li jkun issemma fil-pubblikazzjoni li minnha jitressaq l-ilment; (b) il-fatt imsemmi jrid ikun sostanzjalment minnu; (c) il-kumment irid jintwera li jkun ġustifikabbli jew misthoqq; (d) il-kumment irid ikun tali li jikkwalifika bħala kritika u mhux żebliħ, tghajjir jew insolenza; u (e) irid jagħti l-fehma onesta tal-kummentatur u li l-pubblikazzjoni ta' dik il-fehma ma saritx b'hażen jew bil-ħsieb preċiż li jwegġa' lil dak li jkun.

Tali tagħlim huwa anke rifless f'gurisprudenza estera u, di fatti, fil-kawza **Spiller vs Joseph** deciza mill-Qorti tal-Appell Ingliża fl 1 ta' Dicembru 2010, Lord Phillips għamel is-segwenti konsiderazzjonijiet meta wiehed iqis id-difiza ta' 'fair comment':

A subsidiary but important issue was what it was that a defendant had to prove in order to establish the defence of fair comment. Counsel for the plaintiff submitted that the defendant had to establish that: (i) the words complained of were comment; (ii) the comment was on facts; (iii) the facts commented on constituted a matter of public interest; (iv) the comment was objectively “fair”; that is the comment was one that was capable of being honestly founded on the facts to which it related, albeit by someone who was prejudiced and obstinate; (v) the comment represented the defendant's honest opinion. If he discharged all these burdens, the defence could none the less be defeated by proof of malice on the part of the defendant, but the onus of proving malice lay on the plaintiff. Both the Court of Appeal and the House of Lords held that there was no burden on the defendant to establish the fifth element. The defendant's honesty was assumed unless the plaintiff could disprove it by establishing malice.

“(i) Freedom of expression constitutes one of the essential foundations of a democratic society and one of the basic conditions for its progress and for each individual's self-fulfilment. Subject to paragraph 2 of Article 10, it is applicable not only to 'information' or 'ideas' that are favourably received or regarded as inoffensive or as a matter of indifference, but also to those that offend, shock or disturb. Such are the demands of pluralism, tolerance and broadmindedness without which there is no 'democratic society'. As set forth in Article 10, this freedom is subject to exceptions, which ... must, however, be construed strictly, and the need for any restrictions must be established convincingly ...

Dana huwa rifless anke mit-tagħlim tal-Qrati Ingliżi fejn, Lord Justice Scott, fil-kawza **Lyon v. Daily Telegraph**, qal:

The right of fair comment is one of the fundamental rights of free speech and writing which are so dear to the British nation, and it is of vital importance to the rule of law on which we depend for our personal freedom.
