*Prevoja dikjarazzjoni ta' din Onorabli Qorti illi pubblikazzjonijiet konsistenti f'emails mibghuta mill-intimat u distribwiti lil numru ta' persuni fil-25 ta' April, 2014 u fit-28 ta' April, 2014 huma libelluzi u malafamanti fil-konfront tar-rikorrent billi z-zewg pubblikazzjonijiet fihom dikjarazzjoni cara illi r-rikorrent huwa 'persona non grata' liema dikjarazzjoni, inoltre ghall-fatt illi hija infondata, hija palezement intenzjonata sabiex ittellef jew tnaqqas ir-reputazzjoni tar-rikorrent u sabiex tesponih ghar-redikolu jew ghad-disprezz tal-pubbliku, thallas lir-rikorrent in linea ta' danni dik is-somma li tigi likwidata minn dina l-Onorabli Qorti a tenur tal-Artikolu 28 tal-Att dwar Istampja, Kapitlu 248 tal-Ligijiet ta' Malta.*

*We do not wish to take any action which might impair you and therefore request that you give this matter your most immediate attention.*

*I hope you will understand why we must take this position and your are kindly requested not to send any further emails to us, neither try to harass us or bring our good reputation into disrepute.*

*Dear Insp Cremona,*

*Thanks your email and contents noted.*

*However, this wanted to keep you in the loop of undesirable or unwanted persons and as organisers wanted you to be fully aware of that. We will have our own security and they are being notified accordingly, as we will not allow or permit unregistered persons into the conference.*

*We want to run a smooth operation and you must understand that it is our duty and obligation to keep you informed about this.*

*Trust you understand, as we only want full cooperation, having supplied list to you yesterday”*

Jirrizulta illi fit-28 ta' April 2014 fid-9.37, Ray Borg, illi huwa l-Administration Manager tal-Libyan Maltese Chamber of Commerce, kiteb lill-intimat, fejn għarfu sabiex “to refrain from mentioning the ‘Libyan Business Council’ which is included in your programme of the Forum” għax saħq li “This Co council does not exist in Malta and your reference to such an institution is giving conflicting messages related to our activity as the Chamber that represents Libyan-Maltese business interests”.

Jirrizulta illi għal dina l-email, l-intimat irrisponda permezz ta' email datata **28 ta' April 2014 fil 11.14am**, illi hija t-tieni email illi dwarha jilmenta r-rikorrent fir-rikors promotur tiegħu, email indirizzata, din id-darba, lill Ray Borg, tal-Libyan Maltese Chamber, u kkupjata lill John Formosa, indirizzata wkoll lill Ambaxxata Tunesina u indirizz iehor, illi kienet tghid is-segwenti: (fol 4)

*Dear Ray,*

*I refer to your email below and would kindly draw your attention to the following:*

- A. Please be informed that we had already removed the Libyan-Maltese Chamber form (sic) our programme, which was inadvertently listed in our initial draft; In fact, several amendments have been done as there were change/addenda of speakers, since we have been overwhelmed with requests and registrations for this event.*
- B. Kindly note it is/was never our intention to give out any conflicting messages related with anyone's activity. However, we wish to draw your attention to the fact that we called the Libyan-Maltese Chamber several times without success to inform them about this as no one replied. It was following my initiative last week that I called you personally to inform you that we could not accept the presence of your acting President Mr Anthony Micallef, a persona non grata, for various reasons I mentioned and highlighted, one of them being that Mr Micallef had personally sent threatened us stating he would harm a our future interests and give us a bad name wherever he is, something which is most unbecoming of his position.*
- C. Furthermore, please note that the extract you are quoting is fully correct and your Council is misinterpreting and misleading what is declared, since if you read carefully we are stating that the foreign companies, including the Libyan Business Council, whom we have met together with the representatives of the Libyan Embassy, "are being brought over". In fact, we also sated (sic) together with the Libyan Business Council (of Libya- nothing to do with Malta) in Malta (since the event is taking place in Malta);*
- D. Therefore, we are NOT referring to a Council in Malta, but as correctly and appropriately declared, it is the Libyan Business Council from Libya, who are coming to Mala (sic);*
- E. Therefore, the Council of the Libyan-Maltese Chamber of Commerce is wrong in it assumptions, conclusions and speculation that there is a Libyan Council in Malta and if the Council which you are directed to represent is interpreting it that way, than that is mere speculation and incorrect- something which we condemn and any references you alleged to such an institution is fictional and is meant to give a conflicting view, and/or opinion, which cannot be further than the truth possibly can be;*
- F. Therefore, we repudiate your claim that we are providing conflicting messages in any way, form or manner and so please refrain from trying to give a false impression about us making false declarations, which do not exist.*
- G. It is apparent that the Council of the Libyan-Maltese Chamber of Commerce, which you have been directed, is doing its best to confuse, harm and misinterpret instead of acting out its duties, obligations and roles, according to its statute.*
- H. May I kindly remind you that this event is our initiative and not an initiative which Mr Micallef incorrectly claims to have had; If he wanted to be credible than how come he never did organise this in past an during the long term he has been president of your institution?*

*In light of the above, we kindly request you to **Cease and Desist** from sending us any further emails of this kind, since you are making reference to a Council that does not exist in Malta intentionally to disrupt our good work and reputation, and harm our interests.*

*Moreover, even the fact that you are directing your email to the Tunisian Embassy, is evidence enough your false intentions to create as much confusion and bad light on us and is badly reflecting on your Chamber as this is unprofessional, unethical and comes in bad taste.*

*However, please note that we had already warned the Tunisian Embassy what to expect from in the circumstances and we condemn this behaviour from your Chamber, as we are the sole organisers of this event and any such messages should be directed only to us, as the Tunisian Embassy are not responsible with the publication of any programme, even if they are associated with the event.*

*It is therefore the Council of the Chamber of Commerce, which you have been you directed, that is making reference to such an institution and as such, it is the institution which you representing which is giving conflicting message, and which we distance ourselves from completely.*

*Likewise, we reserve every right of legal action to safeguard all our commercial interests and the good standing and reputation we have earned through our work serving all the business and diplomatic community with outstanding and exceptional results in past.*

*Please be guided accordingly.*

This is an event which is costing us thousands and Mr Micallef is not welcome. He has done events last year and this year and did not want us there, so we respected that and do not want him in any of our events for a number of reasons and We DO NOT want him.*

*We hope you appreciate the fact that we are conceding enough room to accept other members or representatives from the LMCC but Mr Micallef is not wanted and cannot come. I do not have an personal problems with Mr Micallef. Mr Micallef has problems with our company and with interests our company represents, and has tried to defame us and slander us, and is always harming our interests wherever he is. Mr Micallef cannot attend or try to disrupt our event, as we are having to fork out over Euro 25,000 for the organisation and we will hold him fully responsible. I have shown Anhelique just small part of the costs this morning.*

*Please understand this is not a personal issue and it is our collective decision ...*

....

*What we want to see is positive attitude and gestures from Mr Micallef himself not threats, lies and coercion to try to intimidate us. Please note we had already Mr Micallef email to register but he refused, preferred to make an issue out of nothing, insisting to speak, actions which are arrogant, irresponsible and unethical.*

...

*This is not about me or Mr Micallef, it is about Malta-Tunisia-Libya. Mr Micallef is a negative, destructive and obstinate person, as we had given him plenty of opportunities and offered him our handshake in past, but he refused and instead wanted only to harm us. The responsible and positive attitude must come from Mr Micallef and not vice-versa.*

*I suggest brief meeting Monday and I am discussing this during the weekend but if Mr Micallef really wishes to sincerely attend, then he must make a formal apology in front of you and offer his handshake as gentlemen should do, not continue to do things behind our backs. I think we cannot do more than that.*

Jirrizulta wkoll, skond ir-rikorrent, illi wara illi huwa rrifjuta illi jhallas, l-intimat beda jattakka lir-rikorrent u sahsitra, fil 31 ta' Jannar 2014, kiteb email ta' erbgħa faccata shah lill-principali tieghu tal-Konika Minolta gewwa l-Gappun u f'pajjizi ohra, sabiex jattakka lir-rikorrent ta' "*unbecoming and unprofessional behaviour by your representative in Malta, Mr Anthony Micallef of Office Group Ltd*" (fol 62 sa 65).

Qabel ma tigi ikkunsidrata d-difiza ta' l-intimat, ikun opportun illi jigu kkunsidrat certi aspetti legali.

Dwar jekk email jikkwalifikax jew le bhala stampat jew xandira a tenur tal-Kap 248, għandha ssir referenza għall-artikolu principali illi jipprovdi għall-azzjoni odjerna kif ukoll għad-definizzjonijiet pprovdu ti fl-istess Att.

L-Artikolu 3 tal-Kap 248 jipprovdi illi:

*Ir-reati msemmija f'din it-Taqsima ta' dan l-Att isiru permezz tal-pubblikazzjoni jew tqassim f'Malta ta' stampat, ikun x'ikun il-post li minnu jorigina dak l-istampat, jew bil-mezz ta' xi xandir.*

*kull kitba stampata b'tipi tipografiċi jew bil- litografija jew b'mezzi jew proċessi ohra bħal dawn fuq karta jew sustanza ohra, kif ukoll kull kartellun jew avviż ieħor li jitwaħħal li jkun fih xi sinjal jew kitba miktuba, stampata, impingija, riżaltata jew*

*xort'ohra impressa, u tinkludi kull diska, tape, film jew mezz ieħor li bih kliem jew immaġini viżwali jistgħu jinstemgħu, jitwasslu jew jiġu riprodotti;*

L-istess Artikolu jiddefenixxi ukoll il-kelma 'xandir' billi jiddefeniha bhala:

*it-trasmissjoni permezz ta' fili jew minn ġewwa l-arja, inkluża wkoll permezz ta' satellita, f'għamla kodifikata jew mhijiex; ta' kliem jew immaġini viżivi, sew jekk dawk il-kliem jew immaġini jkunu fil-fatt riċevuti minn xi persuna sew jekk le.*

Fil-kaz odjern, għandna komunikazzjoni varja illi saret permezz ta' email. Ghalkemm email ma jidherx illi hija kkunsidrata bhala 'xandir' da parte tal-legislatur, stante illi jidher li xandir huwa aktar intiz bhala dak li jintwera u jissemma fuq it-television u ir-radio, certament tali emails għandhom jitqiesu bhala 'stampat' stante illi l-ligi tikkontempla "jew mezz ieħor li bih kliem jew immaġini viżwali jistgħu jinstemgħu, jitwasslu jew jiġu riprodotti".

Għaldaqstant, il-Qorti ma għandha ebda dubju illi l-kontenut tal-emails huma suggetti għall-legislazzjoni li tirregola l-libelli, ossija l-Kap 248 tal-Ligijiet ta' Malta.

Dwar l-elementi tal-pubblicita' tal-email, il-Qorti tagħmel referenza għal dak illi qal il-**Gately on Libel and Slander** fejn jgħid is-segwenti:

*No civil action can be maintained for libel or slander unless the words complained of have been published. "The material part of the cause of action in libel is not the writing, but the publication of the libel." In order to constitute publication, the matter must be published to (communicated to) party, that is to say, at least one person other than the claimant. "A cannot sue B for defaming him to A himself, or to B himself; that is to say where B reads to himself his libel on A and then locks it away. A must prove that B defamed him to C." Defamation protects a person's reputation and his reputation is not the good opinion he has of himself but the estimation in which others hold him. A defamatory statement about the claimant communicated to the claimant alone may injure his self-esteem but it cannot injure his reputation. The requirement that there be a publication to a third party is also a requirement of malicious falsehood.*

...

*It is not sufficient that the matter has been merely communicated to the third party: it is also necessary that it be communicated in such a manner that it may convey the defamatory meanings and that persons acquainted with the claimant could understand it to refer to him. If, therefore, a defamatory letter was handed to a person who could not read or who could not read the language in which it was written, there would be no publication nor would there be where words were spoken in a foreign language not understood by those who heard them"; and where a defendant sent to a third person on a privileged occasion a postcard defamatory of the plaintiff, though his name was not mentioned, and no stranger unacquainted with the circumstances would have identified him as the person referred to, it was held that there was no publication to the postman or other persons through whose hands the postcard passed."*

Jirrizulta, fil-kaz odjern, illi l-intimat, fiz-zewgt emails illi dwarhom jilmenta r-rikorrenti fil-proceduri odjerni, illi huma biss tnejn minn hafna email skambjati, dawna l-emails ma intbghatux biss lir-rikorrent, izda intbghatu ukoll lill-persuni ohrajn, kemm illi kienu ġia involuti fl-organizzazzjoni tal-konferenza, kif ukoll persuni illi ma kellhomx x'jaqsmu xejn mal-organizzazzjoni, bħalma kienu l-Ispettur George Cremona w il-Kummissarju tal-Pulizija Peter Paul Zammit.

Jirrizulta ghalhekk illi, kif anke jikkontendi l-Gately, ladarba hemm pubblikazzjoni ta' allegazzjoni dwar persuna lill terza persuna, hemm elementi sufficjenti ta' pubblikazzjoni biex dawna l-emails ikunu suggett ta' proceduri ta' libel.

## **Ikkunsidrat**

Jirrizulta, skond ma jinsisti l-intimat, illi r-rikorrent kien gharraq bl-intimat meta ingaggah jaghamillu intervista fuq il-magazine Economic Update u wara ma hallsux, peress illi l-intimat jikkontendi illi r-rikorrent ghamillu dan bi tpattija talli ma xtarax printer minghandu.

Jirrizulta illi, biex jissustanzja tali allegazzjonijiet, l-intimat jsemmi zewgt persuni, Stephen Holland u Andre Ribeiro, illi skond huma kienu huma illi gharrafu li r-rikorrent kien ghamel hekk bie iqarraq bih.

Jirrizulta, madanakollu, illi l-intimat ma tellax lill Stephen Holland u Andre Ribeiro sabiex jikkonfermaw tali fatti, u jistrieħ biss fuq emails illi l-intimat jghid illi gew mghoddija lilu minn Andre Ribeiro, u partikolarment email datata 17 ta' Ottubru 2013 fejn jinghad is-segwent:

*On another note did they ever decide in closing the Production Printing Sale (I am talking of Economic Update). I can always ask them to give us a deposit even if this reflect the money for the advert. This way the sale would be blocked. Please advise. (fol 174)*

Jirrizulta illi l-intimat jikkontendi, fix-xhieda tieghu, illi r-rikorrent ghamel kollox bi tpattija kontra tieghu talli l-intimat ma xtarax minghand ir-rikorrent printer tad-ditta Konika Minolta illi kien jiswa madwar €50,000. (fol 141)

Jirrizulta wkoll illi l-intimat jikkontendi illi l-email datata 17 ta' Ottubru 2013 fuq kwotata hija prova ta' dan.

Il-Qorti, madanakollu, ma tistax ma tosservax, l-ewwel u qabel kollox, illi l-intimat ippresenta zewgt kopji ta' l-istess email, wahda fejn il-kitba fuq riprodotta tinsab miktuba bil-karattri bl-iswed skur, ossija 'bold' (fol 174), u email ohra identitka, izda fejn ma jidher ebda kitba bil-karatti bl-iswed skur ossija 'bold' (fol 184), u l-Qorti ma tistax ma tikkonkludix illi wahda minn dawna z-zewgt emails hija mbaghbsa, bir-rizultat illi ma jistax jigi esklus wkoll illi l-kontenut ta' tali emails gie mbaghbas ukoll.

Apparti minn hekk, il-Qorti ma tistax ma' tosservax ukoll illi, f'kaz illi jitqies illi l-kontenut ta' tali email ma giex imbaghbas, l-email inniffsu jsemmi "Production Printing Sale" illi kien relatat ma' "I am talking of Economic Update" filwaqt illi l-kwistjoni tal-printer li jsemmi l-intimat hija kwistjoni illi tirrigwarda l-magazine Property & Life Magazine, kif jidher mill-email ta' l-intimat a fol 132A tal-process kif ukoll l-Invoice illi tidher a fol 141, liema magazine kienet propjeta esklussiva ta' l-intimat u ma kellhx x'taqsam assolutament xejn mal-magazine Economic Update, illi kienet tad-ditta Network Publications Limited.

## **Ikkunsidrat**

Jirrizulta illi l-intimat jikkontendi illi d-decizjoni illi r-rikorrent jigi dikjarat bhala "persona non grata" ma kienetx tieghu, izda kienet ta' John Formosa, illi kien il-propretarju tad-ditta Network Publications Limited u li kien l-employer tieghu.

Sabiex jikkorroborata tali dikjarazzjoni, huwa pproduca bhala xhud lill Margaret Brincat, illi kienet tahdem flimkien ma' l-intimat gewwa Network Publications Limited u li bejniethom kien hemm relazzjoni.

Jirrizulta, madanakollu, illi l-intimat naqas illi jipproduci lill John Formosa, illi kien ikun l-ahjar prova sabiex jiskolpa lilu nniifsu mill-kontenut tal-varji emails illi l-intimat jghid li gew dejjem iddettati minn John Formosa.

Il-Qorti, madanakollu, ma tistax ma tosservax illi, fil-brochure illi kien gie prodott sabiex jippromuovi il-Malta-Tunisia-Libya B2B Networking Forum 2014 illi kien qieghed jigi organizzat u illi dwaru inqalghu dawn id-disgiwidi kollha li wasslu ghall-emails meritu tal-kawza odjerna, hemm miktub bl-aktar mod car is-segwent:

“The Economic Update’s editor MartinVella is organising a one day business even comprising of conference, forum with open debate, networking activities, exhibition display stands and entertainment”

Tali dikjarazzjoni tidher illi hija diametrikament opposta ghal dak illi jittenta x'jaghti jifhem l-intimat fil-proceduri odjerna, peress illi l-Qorti ma ghandhiex dubju illi kieku kien attwalment minnu illi John Formosa u d-ditta Network Publications Limited kienu attwalment qed jmexxu l-organizzazzjoni huma stess, certament ma kienux jippermetti illi jinkiteb fil-brochure ufficjali illi kollox kien qieghed isir mill-intimat biss!

Ghaldaqstant, hija difficili li titwemmen u inverosimili illi ma kienux l-intimat illi baghat l-emails meritu tal-kawza odjerna, u dana huwa anke sopportat mill-varji emails illi esebew iz-zewgt partijiet, inkluz l-email twila illi baghat l-intimat lill-Konika fil-Gappun fil 31 ta' Jannar 2014, illi lkoll ghandhom l-istess format u forma mentis fihom - dak illi jattakkaw lir-rikorrent u joskurawh ma kullmin qieghed jaqra l-email.

## **Ikkunsidrat**

Il-Qorti, finalment, ma tistax ma taghmilx is-segwent osservazzjonijiet:

L-intimat, fid-difiza tieghu, jipprova jiggustifika il-kontenut tal-emails tieghu billi jghid zewgt argumenti principali:

1. Illi *“ir-rikorrent inniifsu kien palezement idejjaq lill- esponent biex bi prepotenza jattendi u jkun kelliem ewlieni f'attivita organizzata mill-esponent ghan-nom tas-socjeta li jirraprezenta bla ma kien invitat li jaghmel dan u li sahansitra l-istess rikorrent kien sostna li kien ser jaghmel il-hsara lill esponent”*
2. Illi *“id-decizjoni li ir-rikorrent giet dikjarat persona non grata ma hadhiex l-esponent imma mill kumitat organizzattiv ta' l-event in kwistjoni”*.

Mill-provi prodotti, jirrizulta bl-aktar mod car illi l-Ambaxxata Tunesina, illi kienet qabddet lill-intimat sabiex jorganizza l-event, kienet tassew stiednet lir-rikorrent sabiex jitkellem, kemm verbalment kif ukoll ufficjalment, izda kien l-intimat illi kien qieghed jirrifjuta bis-sahha li l-intimat ma jitkellimx u baqa jirrifjuta sakemm attwalment ma marx ghall-attivita', la ir-rikorrent u hadd mill-Libyan-Maltese Chamber of Commerce.

Mill-provi prodotti jirrizulta wkoll illi l-intimat f'ismu kien qieghed jorganizza l-attivita' u ma kien hemm ebda kumitat organizzattiv, kif jalludi l-intimat fid-difiza tieghu. Ma ngiebet ebda tip ta' prova li turi l-involvement ta' John Formosa jew persuni ohra fit-tmexxija tal-konferenza.

Fl-ahhar nett, il-Qorti ma tistax ma tosservax illi, l-fatt illi persuna jkollha problema ma' persuna ohra u ghalhekk ikun irrabjat ma' tali persuna ghal xi azzjoni illi huwa jhoss illi saret kontrih, ma jaghtih ebda licenzja sabiex jattakka ir-reputazzjoni tal-persuna l-ohra ma persuni ohra illi huma ghal kollox barra minn tali kwistjonijiet u illi ma kellhom ebda involvement fil-kwistjoni ta' bejniethom.

Il-fatt illi l-intimat hass il-htiega li jiccirkola l-email b' allegazzjonijiet u deskrizzjoni tar-rikorrent bhala '*persona non grata*' u "*undesirable or unwanted person*" mal-Kummissarju tal-Pulizija u membri gholja ohra tal-Korp tal-Pulizija, kif ukoll l-Ambaxxatrici Tunesina juri l-intenzjoni cara ta' l-intimat - illi jaghmel hsara lir-rikorrent u jipprova jimmalfama u jhassar ir-reputazzjoni tar-rikorrent ma' tali persuni.

Tali fatt, wahdu, huwa sufficjenti biex il-kaz kollu tar-rikorrent jigi ppruvat u kwalswiasi difiza illi qajjem l-intimat tkun meghluba.
