Ra l-avviz fl-ismijiet premissi pprezentat fid-9 ta' Frar, 2021¹ permezz ta' liema s-socjeta' attrici talbet li l-konvenuti jhallsu s-somma kumplessiva ta' elfejn, mitejn u zewg Ewro u sitta u sebghin centezimu (€2,202.76) rapprezentanti merca li giet mibjugha u kkonsenjata lil konvenuti, liema somma qatt ma giet imhallsa; bl-ispejjez, u d-drittijiet u l-imghaxijiet legali inkluz dawk tal-ittra ufficjali bin-numru 867/2020, b'riserva ghal kwalsiasi ammont ulterjuri li talvolta jista jkun dovut lis-socjeta' attrici.

Ra r-risposta tal-konvenut Christopher McKay pprezentata fid-29 ta' April, 2021² li eccepixxa s-segwenti:

It-talba tas-socjeta' attrici ghandha tigi michuda, bl-ispejjez kontra l-istess, u dan ghaliex:

1. Illi in linea preliminari, l-esponenti ma huwiex il-legittimu kontradittur u dan 'l ghaliex m'ghadux jokkupa l-kariga ta' direttur tas-socjeta' Tapaz Malta Limited (C-79769), u ghaz-zmien indikat fl-istatement, ma kienx direttur anqas, u ghaldaqstant ghandu jigi liberat mill-osservanza tal-gudizzju.
2. Bhala parti mill-process tagghom, is-socjeta' attrici titlob li min ikun qed jiggstixxi n-negozju jidhol responsabbli personalment anke huwa. Is-somma ta' elfejn, mitejn u zewg Ewro u sitta u sebghin centezimu (€2,202.76) ghadha dovuta.

Ra x-xhieda ta' **Christopher McKay**⁶ fejn qal li s-socjeta' Tapaz Malta Limited kienet kumpanija li fetah huwa fis-sena 2017, pero' wara madwar ghaxar xhur minn meta fetah tali kumpanija kien hemm persuna ohra li hadet over hija, u ghalhekk ilu ma huwiex involut f'tali kumpanija minn Frar/Marzu, 2018. Warajh dahlet persuna ta' nazzjonalita Svediza bl-isem ta'

Patrick Bo Alfvegren, u esebixxa diversi dokumenti inkluz estratt mill-MFSA.⁷ Kompla jispjega li minn dawn id-dokumenti hemm indikat minn huma l-persuni ufficjali fi hdan is-socjeta konvenuta u li m'ghandu l-ebda involvement ma din is-socjeta'. Fuq parir legali li kien ha dak iz-zmien hu kien iffirma skrittura mal-persuna li eventwalment akkwistat l-ishma tal-kumpanija konvenuta u li permezz taghha huwa ddikjara li fir-rigward tad-djun u krediti tal-istess socjeta' huwa ma kellu xejn x'jaqsam iktar u kien ser ikun responsabbli ghalihom l-istess persuna li xtrat il-kumpanija minghandu.⁸ Qal ukoll li fiz-zmien li kien hemm huwa, ma halliex djun, u li sa fejn jaf hu djun tal-kumpanija ma kienx hemm. Kompla jispjega li jekk kien hemm djun dawn kienu djun noramli assocjati mal-operar tal-istess kumpanija minn zmien ghal zmien. Fuq l-*istatement* li jidher li hareg mis-socjeta' attrici, u rrefera ghad-data indikata u cioe' Settembru, 2019, spjega li dak iz-zmien kien ilu li waqaf mis-socjeta' konvenuta. ... warajja dahal persuna ta' nazzjonalita' Svediza Patrick Bow Alfiden. Ilni mhux involut f'din il-kumpanija minn Frar / Marzu tal-2018.

Mir-Registru tal-Kumpaniji jirrizulta illi d-Direttur, rapprezentant legali u rapprezentat gudizzjarju huwa Bo Patrick Alfvegren (K.I. 39421A) filwaqt illi s-shareholder hija Mindy Elsebeth Alfvegren (K.I. 183139A).¹⁰

Qed issirli referenza ghal fol 5 u naqbel ma' dak li qed jigi suggerit lili illi hemm kaxxa li trid tigi mimlija mill-garanti personali. Naqbel ukoll illi f'dan il-kaz din il-kaxxa ma ntlietx.

Ikkunsidra l-*credit application* u l-awtorizzazzjoni ghall-*Informazzjoni tal-Bank* u Referenza¹¹ datati 31 ta' Mejju, 2017 u ffirmati mill-konvenut Christopher McKay. Ra li klawsola 8 tat-*Terms & Conditions of Credit* jghid is-segwenti:

8. Credit Terms Personal to Reseller

*The Reseller accepts that any credit terms granted by the Creditor Company apply only to the Reseller and undertakes to inform the Creditor Company in writing, within 7 days, of any change in the ownership, management or responsibility of the business from which the Reseller sells the Products. The Reseller shall lose the benefit of the credit terms hereunder, in the event that the Reseller fails to inform the Creditor Company of any such change, or in the case of a breach of any clause in these Terms of Credit.*¹²

Ikkunsidra li l-konvenut Christopher McKay iffirma d-dikjarazzjoni li tghid:

I/we have read the attached terms of sale and accept and agree to comply with your payment terms of 60 days from invoice month end (unless otherwise agreed by you

in writing) and to adhere to the credit limits imposed on each individual group company.

I/we give my/our consent to initiate a debt recovery process to which I/we will cooperate fully.¹³

Izda ma ffirmax id-dikjarazzjoni li tghid:

The Guarantor hereby constitutes himself/herself, a joint and several debtor with the Reseller, in favour of the Creditor Company, which accepts, in respect of the Reseller's obligations under these Terms of Credit. All the parties to this Agreement that the Creditor Company has the right, at its option, to proceed for the recovery of any balance due hereunder against either the Reseller or the Guarantor or against both the Reseller and the Guarantor at the same time.¹⁴

I will assume **ALL retroactive responsibility and liability** of **TAPAZ Malta Ltd.** and will indemnify and keep indemnified Mr. Chris McKat holder of Identity card number 32891M and resident at 19, Triq il-Farfett, Marsa for all matters related to **TAPAZ Malta Ltd.** for any present claims and any other claims which may arise in the future*
