The Court,

Having seen that accused Jewel Cherie Nielsen, 19 years, daughter of Richard and Pamela, born on 01.07. 1983 in the UK, residing at 13, Flat 3, Isourd Str, St.Paul's Bay and Holder of British passport number 452520609 was charges with having:

On these Islands on 23 October 2002, at about 03.00pm, committed the theft of a pair of shoes from Eurosport of Bay Street Complex, St. Augustine Street, St. Julians, which shoes cost more than Lm 10 but less than Lm 100

to the detriment of Michele Peresso Ltd., Eurosport, and other persons, and this in breach of articles 284 of Chapter 9 of the Laws of Malta;

And furthermore, on the same day, time and circumstances;

Reviled, threatened, or caused bodily harm to Insp. M. Tonna, WPS 131 N. Leotta, PS 1492 J. Pace and WPC 174 J. Bonello, persons charged with a public duty, while in the act of discharging their duty or because of them having discharged such duty, or with intent to intimidate or unduly influence them in the discharge of such duty, in breach of Article 95 of Chapter 9 of the Laws of Malta;

Disobeyed the lawful orders of any authority or of any person entrusted with a public service, or hindered or obstructed such person in the exercise of their duties, or duly interfered with the exercise of such duties, either by preventing other persons from doing what they are lawfully enjoined or allowed to do, or frustrating or undoing what has been lawfully done by other persons, or in any other manner whatsoever, in breach of Article 338 (ee) of Chapter 9 of the Laws of Malta;

Having seen that accused admitted the charge.

Finds her guilty.

Having seen sections 261, 284 and 338 (ee) of Chapter 9 of the Laws of Malta and section 9 of Chapter 152 of the Laws of Malta decides to apply the last mentioned section in virtue of accused clear conduct.

While finding accused guilty of the said charges discharges her under the provisions of section 9 of Chapter 152 of the Laws of Malta provided that accused shall not commit another crime within three months from today.
