## POLICE INSPECTOR ANTHONY PORTELLI VS GINA MUHLOVA EVDOKIYA MUHLOVA

#### The Court,

Having seen the charges brought against the accused Gina Muhlova, of 33 years, daughter of Nacho Muhlov and Evdokiya nee' Miteva, born at Bulgaria on the 23<sup>rd</sup> December 1973, and residing at Room 501, Europa Hotel, Tower Road, Sliema, and holder of Bulgarian identity card number 152480903; and Evdokiya Muhlova, of 54 years, daughter of Nacheva Muhlova and Gina nee' Miteva, born at Bulgaria on the 2<sup>nd</sup> June 1953, and residing at Room 501, Europa Hotel, Tower Road, Sliema Hotel, Tower Road, Sliema, and holder of Bulgarian identity card number 152349526;

and charge them with having, on these Islands, on the 19<sup>th</sup> and 20<sup>th</sup> September 2007, by means of several acts, committed at different times in pursuance of the same design and which constitute violations of the same provisions of the law.

Charge them with having at Valletta on the 19<sup>th</sup> September 2007, at about 10.20am, committed theft of a hand bag containing one hundred and fifty Maltese Liri (Lm150), in cash and other items, which theft is aggravated by amount that exceeds the sum of one hundred Maltese Liri (Lm100), but not exceeding one thousand Maltese Liri (Lm100), to the detriment of Nadia Bugeja of Mgarr (Malta) and/or other persons.

And furthermore, with having at Sliema, on the 20<sup>th</sup> September 2007, at about 6.20pm, committed theft of a purse from the person of Evellina Jones of Valletta, who is a senior citizen (over 60 years of age).

Having heard the evidence tendered on oath;

Having seen the record of the proceedings;

Having heard the plea of admission entered by the accused;

Having heard the confirmation of the plea of admission registered by the accused, after they were given reasonable time by the Court to reconsider their plea;

Having heard the oral submissions of the parties;

Considers:-

On the grounds of their admission, the Court finds the accused guilty as charged and after having seen Articles 18, 261, 267, 278, 279 and 28A of Chapter 9 of the Laws of Malta, condemns them to fourteen (14) months imprisonment suspended for two years.

The plea was given after the Court has seen all the circumstances of the case, including the fact that they registered their admission in an early stage of the proceedings, and the fact that they are first offenders.
