**The Court;**

After seeing the charges brought against:

Ivanka Nedyalkova Nikolova of 47 years, daughter of Nikola Mitef and Elenka nee' Georgieva, born in Sliven, Bulgaria on the 5<sup>th</sup> June 1961, holder of Bulgarian identity card no: 112665683 and residing in an unknown address;

And

Stanka Aleksandrova Mladenova of 30 years, daughter of Mladen Ivanov and Stefka nee' Markova, born in Pleven, Bulgaria on the 26<sup>th</sup> June 1977, holder of Bulgarian identity card no: 140122673 and residing in an unknown address

For Having:

1) On the 11<sup>th</sup> June 2008, at about 11.30hrs, whilst at BHS, situated at The Strand, Sliema, committed theft of wallet to the detriment of Kevin Robinson from the United Kingdom, which offence of theft is aggravated by amount when the value of the thing stolen exceeds two hundred and thirty- two euro and ninety-four cents (232.94), but not exceeding two thousand and three hundred and twenty-nine euro and thirty- seven cents (2,329.37);

2) On the 10<sup>th</sup> June 2008, at about 18.00hrs, whilst at Wallis retail outlet, situated in Tower Road Sliema, committed theft of wallet to the detriment of Jane Psaila from Msida, which value exceeded twenty- three euro and twenty- nine cents ( 23.29), but did not exceed two hundred and thirty-two and ninety- four cents (232.94)

After having heard the evidence and the documents exhibited;

After having heard the accused file a guilty plea to the charges brought against them, after having been given due time to consider the admission to these charges according to law;

Considers:

After having seen the Articles 261, 267, 289 OF Cap 9 of the Laws of Malta;

Finds the accused guilty as charged and condemns them to a period of six (6) months imprisonment suspended for two (2) years, in terms of Article 28A of Chapter 9 of the Laws of Malta.
