**Having seen the charges laid against**

**Dean Boyd, 16 years of age, born on the 28th June 1992 in Belfast United Kingdom, son of Paul and Donna holder of British Passport number 652056937, residing whilst in Malta at The Clock Place Apartments, Flat no Triq il-Port Ruman Qawra St Paul's Bay and in England at no 80 London Street Belfast, United Kingdom.**

**And**

**Jonathan Sykes, 17 years of age, born on the 19th September 1990 in Belfast United Kingdom, son of Jonathan and Allison nee' Boyd, holder of British passport number 6510705451 residing whilst in Malta at The Clock Place Apartments, Flat no Triq il-Port Ruman Qawra St Paul's Bay and in England at 3 Houston Road Cross Nacreedy Belfast United Kingdom**

**And**

**Ryan Sykes, 16 years old, born on the 8th April 1992 in Belfast United Kingdom, son of John and Alison nee' Boyd, holder of British passport number 650977532 residing whilst in Malta at The Clock Place Apartments, Flat no Triq il-Port Ruman Qawra St Paul's Bay and in England at 3 Houston Road Crossnacreevy Belfast, United Kingdom**

**And**

**Gary Herron, 22 years old, born on the 10th February 1986 in Belfast United Kingdom, son of Stephen and Lilinda nee' Brown, holder of British passport number 651335533 and residing whilst in Malta at The Canifor Hotel, Room 108 Triq il-Maskli San Pawl il-Bahar and at 54 Castle Lodge, Randalst Antrim, United Kingdom**

**And**

**Mark Aiken, 16 years of age, born on the 6th August 1991 in Belfast United Kingdom, son of Trevor and Margareth nee' Mc Culure, holder of British passport number 651670631 and residing whilst in Malta at The Palm Court Hotel, room 557, Triq it-Tamar, ST. Paul's Bay and at 1, Ilford Avenue, Belfast, United Kingdom.**

**Accused for having on the night between the 17th and 18th July 2008 in Bugibba ST. Paul's Bay sometime between 01.00hrs and 05.00hrs having tried to commit the theft of a vehicle bearing registration number FQZ 235 which theft amounts to more than 233 Euro**

Kopja Informali ta' Sentenza

**(LM100) and less than 9,320 Euro (LM4000) which crime was not committed because of something accidental and independent of their free will, which theft is aggravated by means, amount and time to the detriment of third parties.**

**Having seen the guilty plea filed by the five defendants, which guilty plea they confirmed after giving them enough time to think about it.**

**Hence the charge has been proved in accordance with the law.**

**The Court, after seeing sections 37, 41(1)(a), 261(b)(c)(f), 263, 270, 267, finds the defendants guilty but instead of condemning them, it is discharging them on condition that they do not commit another crime within two years.**

**The Court explained to the defendants Section 22 of Chapter 446.**

**The judgement is to be sent to the AG's office.**
