The Court,

Having seen the charges brought against the accused :

1. Georgi Hristov Hristev, 25 years, a Bulgarian national, son of Hristo, born at Plovdiv on the 17<sup>th</sup> February 1976, and has a passport bearing number 318503672;
2. Boyan Lenkov Kushev, 26 years old, a Bulgarian national, son of Petkov Nilan, born at Kanzanlak on the 28<sup>th</sup> September 1975 and without a passport;
3. Eleonora Hristova Nikolova, 24 years old, a Bulgarian national, daughter of Hristo, born at Varna on the 3<sup>rd</sup> June 1977 and having a passport bearing number 300492803;
4. Iliya Iliev, 52 years old, a Bulgarian national, son of Gerogi, born at Varna on the 7<sup>th</sup> November 1949 and without a passport.
5. Djordje Stamenkovic, 37 years old, a Yugoslav national, son of Mihailo, born at Arot on the 30<sup>th</sup> March 1964 having a passport bearing number 001574419;
6. Ivan Timic, 23 years old, a Yugoslav national, son of Stevan, born at Uzice on the 6<sup>th</sup> March 1978 having a passport bearing number 002441019;
7. Goran Dzunic, 36 years old, a Yugoslav national, son of Miodrag, born at Pirot on the 2<sup>nd</sup> July 1965 having a passport bearing number 002194544;
8. Dragomir Sparic, 22 years old, a Yugoslav national, son of Jovan, born at Uzice on the 7<sup>th</sup> April 1979 and without a passport.
9. Ranko Savic, 49 years old, a national from Bosnia and Herzegovina, son of Milan and born at Kalinovik, and holder of passport bearing number 1437053;

**10.**Alexandru Ionut Casian, 22 years old, of Romanian nationality, son of Constantin, born at Iasi on the 14<sup>th</sup> February 1979 and without a passport;

For having during the past months and weeks, without having been granted a residence permit, landed or were in Malta without leave from the Principal Immigration Officer.

Having seen that the accused pleaded guilty.

Finds the accused guilty;

Having seen Article 14 of Chapter 217 of the Laws of Malta and Article 28A of Chapter 9, decides to apply the last mentioned Article in view of the clean conduct of the accused.

Condemns the accused **six (6) months imprisonment each, which sentence shall not come into effect unless the offenders commit another offence punishable with imprisonment, within two (2) years from today.**

Having seen the Prosecution`s request in terms of Section 14 of Chapter 217 of the Laws of Malta, grants the request and orders the issue of a removal order from these Islands against all the accused.
