Having seen the imputations proffered against the accused:

Mahad Mohamed Mohamud, Somali National, son of Mohamed and Moge Farah, born in Mogadishu, Somalia on the 1<sup>st</sup> of January 1979, and known with Police Number 08ZZZ-022;

Anisa Abdulla, Somali National, daughter of Abdi and Ader, born in Mogadishu, Somalia on the 1<sup>st</sup> of January 1983, and known with Police Number 08KKK-007;

Isa Idris, Bukina Faso National, son of Sadi and Hagra, born in Wagadu, Burkina Faso on the 5<sup>th</sup> of September 1981, and known with Police Number 06FF-025;

and

Ahmed Degaj Ali, Somali National, son of Ali and Dakal, born in Mogadishu, Somalia on the 1<sup>st</sup> of January 1991, and known with Police Number 09D-208;

And charge them with having:

1. On the 3<sup>rd</sup> March 2010 in these islands forged, altered or tampered with Passports, ID cards and Residence Permit Cards or used or had in their possession Passports, ID cards and a Residence Permit Card which they knew to be forged, altered or tampered with, in the name of Ali Abdirhman Mario bearing numbers 40112 and AR153118 respectively, in the name of Maryan Ali Omar bearing numbers 759749 and AM7153729 respectively, in the name of Chris Sare bearing numbers 930276, AR4433220 and SRM795045 respectively, and in the name of Ahmed Ali Hassan bearing numbers 22104, AR143129 and 2665425 respectively (Cap 61, Sec 5 of the Laws of Malta);

2. Also with having on the same date, time and circumstances committed any other kind of forgery, or have knowingly made use of any other forged document,

in the mentioned documents (Cap 9, Sec 189 of the Laws of Malta);

3. And also with having on the same date, time and circumstances forged any document or true copy of a document or an entry made in pursuance of this act (Cap 217, Sec 32 (1d) of the Laws of Malta);

Having heard them all plead guilty, finds them guilty as accused;

Having given them time to reconsider;

Having heard all the accused re-confirm their plea of guilty as charged;

Finds them all guilty as charged;

Having seen article 5 of Chapter 61 of the Laws of Malta, article 32 (1) (d) of Chapter 217 of the same Laws and article 189 and 17 (b) of Chapter 9 of the said Laws, condemns the accused to imprisonment for a period of six (6) months from today.
