The Court,

Having seen the records of the proceedings against the  
accused, namely, with having on the 29<sup>th</sup> August, 2010  
and in the preceding weeks in Malta:

1. with the intent to make any gain whatsoever aided,  
assisted, counseled or procured any other person to enter  
or to attempt to enter or to leave or attempt to leave or to  
transit across or to attempt to transit across, Malta in  
contravention of the laws thereof or in Malta, conspired to  
that effect with any other person;

2. aided or assisted any person to land or attempt to land in Malta, or to reside in Malta, contrary to the provisions of the Immigration Act, or any person to land or attempt to land, or to reside in, or to leave any other State contrary to the law on entry, residence and exit of that State;
3. without lawful authority used or had in his possession any document required for the purposes of the Immigration Act which is forged;
4. forged, altered or tampered with any passport or used or had in his possession any passport which he knew to be forged, altered or tampered with.

Having seen the records of the case of the 22<sup>nd</sup> September, 2010 wherein the accused admitted to the charges as proffered.

Having seen the note of the Attorney General of the 19<sup>th</sup> day of October, 2010 whereby he declared that after examining the record of proceedings of the preliminary investigation against the accused and having found that there might result an offence or offences under the provisions of:

- a. article 337A(1) of the Criminal Code;
  - b. article 32(1)(a)(f) of Chapter 217 of the Laws of Malta;
  - c. article 5 of Chapter 61 of the Laws of Malta;
  - d. sections 17, 31 and 533 of the Criminal Code;
- transmitted the said record to this Court to decide upon such offence or offences.

Having seen the records of the case of the 18<sup>th</sup> November, 2010 whereby the accused gave his consent the this case be tried summarily.

Having seen the records of the case of the 18<sup>th</sup> November, 2010 whereby the accused admitted to the charges as proffered.

Having heard the prosecution and defence counsel for the accused with regard to punishment.

Kopja Informali ta' Sentenza

Consequently, this Court finds the accused guilty of the charges as proffered. Having seen article 337A(1) of the Criminal Code, article 32(1)(a)(f) of Chapter 217 of the Laws of Malta and article 5 of Chapter 61 of the Laws of Malta condemns the accused to a period of one year imprisonment.
