The Court;

Having seen the charges brought against accused Calin Doru and omissis who were charged with having in these islands on the 15th August, 2009 at about half past four in the morning (04:30am) from inside 'Footloose Bar'

situated at St. George's Road, St. Julians/or from the vicinity of said Bar:-

1. Committed theft of a bag which contained Euros 50 in cash, mobile phone make LG costing Euro 250 to the detriment of Firniksz Dorina, and also Euro 50 in cash, mobile phone Sony costing Euro 200 and mobile phone make Sony costing Euro 300 to the detriment of Stella Devenyi which theft is aggravated by 'time' and 'amount' (more than Euro 232.56 and less than Euro 2325.58).

2. Accused them further that on the same date, time, place and circumstances, wilfully committed any spoil, damage or injury to or upon movable or immovable property (mobile phone make LG and mobile phone make Sony) which damage exceeds Euro 116.47 (Lm50) but not the amount of Euro 1164.7 (LM500) to the detriment of Firniksz Dorina and Stella Devenyi.

Having seen documents exhibited;

Having heard accused Calin Doru admit to the charges brought against him which guilty plea was reaffirmed

when the Court gave him adequate time to reconsider same;

Having heard submission regarding the punishment to be inflicted;

Considers;

The in view of the guilty plea filed by accused Calin Doru the Court cannot but find him guilty as charged.

That in considering the punishment to be inflicted the Court is taking into consideration the admisión of guilt filed by accused Calin Doru and his clean conduct record. Also the Court is taking into consideration the fact that accused Calin Doru has spent three (3) months under preventive custody and consequently the Court deems it fit to apply Section 21 of the Criminal Code in the circumstances.

Consequently the Court after having seen Section 21, 17(h), 261(c)(f), 267, 270, 280(1) and 279(a) of Chapter 9 of the Laws of Malta finds accused Calin Doru guilty as charged and condemns him to a period of three (3) months imprisonment which term of imprisonment after having seen the above made considerations and Section 28A of Chapter 9 of the Laws of Malta is being suspended for one (1) year.

The Court warns the person found guilty of the consequences according to law should he commit another crime during the period of this sentence.
