The Court,

Having seen that the accused Vladimir Savija, holder of Serbian passport number 8679710, Mirolad Pavlic holder of Serbian passport number 010880010 and Dzepina Goran holder of Serbian passport number 007944783. Informal Copy of Judgement

Were charged with having:

On the 17th July 2012, at abount nine o'clock in the evening (21:00hrs) whilst at Paola, precisely at the Hibernians football club stadium and its perimeters, assaulted or resisted by violence or active force not amounting to public violence, several members of the police who are lawfully charged with a public duty when in the execution of the law or of a lawful order issued by a competent authority;

And also with having on the mentioned date, time, place and circumstances, reviled, or threatened, or caused a bodily harm to any person lawfully charged with a public duty while in the act of discharging their duty or because of their having discharged such duty, or with intent to intimidate or unduly influence them in the discharge of such duty;

And also with having disobeyed the lawful orders of any authority or of any person entrusted with a public service, or hindered or obstructed such person in the exercise of his duties, or otherwise unduly interfered with the exercise of such duties, either by preventing other persons from doing what they are lawfully enjoined or allowed to do, or frustrating or undoing what has been lawfully done by other persons, or in any other manner whatsoever;

And moreover with having on the same date, time place and circumstances took an active part in an assemply of ten or more persons for the purpose of committing an offence, although the said assembly may not have been incited by any one in particular, which offence was in actual fact committed;

And also with having on the same date, time, place, and circumstaces, incited an assembly of persons, ten or more in number, for the purpose of committing an offence which offence was in actual fact committed;

And also with having on the same date, time, place and circumstances not being officials, persons taking part in

the game and not being authorized either by the authority or association under the auspices of which the game is being held or by the crowd management, tresspassed beyond the fence or barriers surrounding the pitch and entered the field of play;

And moreover with having on the same date, time, place and circumstances, willfully disturbed the public good order or the public peace;

And moreover with having on the same date, time, place and circumstances, in any public place or place open to the public, were found drunk and incapable of taking care of themselves.

After seeing the examination of the accused whereby they registered a guilty plea and the confirmation of such plea after being given the opportunity to reconsider their plea; and

After seeing Articles 17(d) and (h), 95, 96(b) and 338 of Chapter 9 of the Laws of Malta, finds Vladimir Savija, Mirolad Pavlica and Dzepina Goran guilty of the charges brought against them and by virture of Article 22 of Chapter 446 of the Laws of Malta frees them on condition that they do not commit another offence with three (3) years from today.

Finally, explained in simple words the repercussions if such order is not complied with.
