**Waldemar Wiezek**

**Today 14<sup>th</sup> February, 2014**

**The Court;**

After having seen the charges brought against:

**Waldemar Wiezik**, of 54 years, son of Roman and Wanda nee' Buk, born in Poland on the 20/07/1959, does not have a fixed address and holder of Polish passport number BM9943250;

And accused him with having between the 19<sup>th</sup> February 2008 and the 04<sup>th</sup> April 2008 in these islands:

1. Committed theft of different items from onboard a vessel with the name '*Blue Diamond*' which theft is aggravated by Means, and the Amount with does not exceed the value of €2329.37 to the detriment of German national Knut Kuntze and/or other person/s, entity and/or entities.

Furthermore, accused him for having on the 13<sup>th</sup> February, 2014 at about 1100 hrs and the previous months in St. Paul's Bay, Naxxar and/or other places in these islands, by several acts, even if committed at different times, which constitute violations of the same provision of the law, and were committed in pursuance of the same design;

2. Committed theft of wine and other items from Scotts Supermarket, which theft is considered to be simple theft to the detriment of Joseph Micallef and/or other person/s, entity and/or entities;

3. Also for having committed a crime punishable with imprisonment during the operative period of a Conditional Discharge for a period of two (2) years imposed on him by Mgt. Dr. A. Mizzi LL.D. on the 22/11/2012.

The Court was also requested to treat Waldemar Wiezik as being a recidivist, after being sentenced for an offence by the Criminal Court on the 19/05/2010 which sentence has become absolute according to Art. 49, 50 and 289 of the Laws of Malta.

The Court;

Having seen the accusations and the Law;

Having seen the Attorney General's Consent for these proceedings against Waldemar Wiezik to be dealt with summarily;

Having heard his guilty plea;

Having asked whether he wanted to re-consider;

Having heard his guilty plea once again;

The Court is finding the accused guilty of all accusations being made and with regards to the first (1<sup>st</sup>) accusation, condemns him to imprisonment for one year (1) suspended for two years (2) and with regards to the second (2) and third (3) accusation, the Court is extending the conditional discharge issued on the 22<sup>nd</sup> November, 2012 for a period of three (3) years from the date the conditional discharge was issued.
