David Christopher Street

The Court,

Having seen the charges brought against the accused David Christopher Street, 56 years old, son of late Henry and late June Parr, born in Cambridge Britain on the 17th February 1958, holder of UK passport 801628219 and Maltese ID 0058088A, residing in Apt 1, Olive Tree, Triq Prehistorja Xemxija and 14, The Quadrangle Centre, the Drift Ipswich IP3 9QR with having committed several acts, even if at different times, which constitute violations of the same provision of the law, and are committed in pursuance of the same design on the date of 26th May 2014, and during the previous period from this date in Malta International Airport and in the Maltese Islands such acts shall be deemed to be a single offence, called a continuous offence

1. As a person responsible or making use of vehicle Peugeot original registration S819 CEB, was making use of said vehicle without any valid insurance;
2. As a person responsible or making use of vehicle Peugeot original registration S819 CEB, in order to gain any advantage or benefit for himself or others made a false declaration or gave false information with stolen numberplates JCD 100;
3. As a person responsible or making use of vehicle Peugeot original registration S819 CEB, was making use of said vehicle without a valid VRT;
4. As a person responsible or making use of vehicle Peugeot original registration S819 CEB without a valid licence disc issued in respect of said vehicle;
5. As a person responsible or making use of vehicle Peugeot original registration S819 CEB was in possession of said vehicle which has not been registered with the competent Authority;

6. As a person responsible or making use of vehicle Peugeot original registration S819 CEB said vehicle was not bearing the number plates that have been issued by the Maltese Authority and they refer to and belong to that particular vehicle (JCD 100 belonging to a DAF truck (vide PIRS 9/T/518/2012));
7. As a person responsible or making use of vehicle Peugeot original registration S819 CEB, was making use of a motor vehicle registration mark other than that allotted by the Authority in relation to a particular vehicle;
8. As a person responsible or making use of vehicle Peugeot original registration S819 CEB, imported or brought into Malta said vehicle without registering it with the Maltese Authority;
9. As a person responsible or making use of vehicle Peugeot original registration S819 CEB, was making use of said vehicle without a circulation licence issued by the Authority and renewed annually;
10. Was making use of an unlicensed vehicle which make Peugeot (original registration S819 CEB);
11. Was making use of vehicle Peugeot original registration S819 CEB with a changed number plates other than those one issued by the Authority and hindered any person from taking note thereof.

The Prosecution requested the seizure of the corpus delicti upon conviction.

Having seen documents exhibited;

Having seen the Attorney General's Consent for proceedings to be dealt summarily and having heard that the accused has no objection to this.

Having heard the accused plead guilty to the charges brought against him, notwithstanding the fact that the Court warned him in the most solemn manner of the legal consequences of his guilty plea after having given him sufficient time within which to reconsider and withdraw his guilty plea;

Having heard the prosecution and defence counsel make their submissions.

Considers:

Having heard the guilty plea of the accused to the charges brought against him the Court has no alternative but to declare the accused guilty of all the charges brought against him.

With regards to punishment the Court took into consideration the fact that the accused pleaded guilty at an early stage of the proceedings, the circumstances of the case, and that he co-operated with the Police.

In view of the above the Court after having seen articles 18, 188, 188(1) of Chapter 9 of the Laws of Malta, Articles 3(1) and 3(2A) of Chapter 104, Articles 15(1A), 19, 27 of Chapter 65, Regulation 3 of Subsidiary Legislation 65.15, Regulations 13(1), 6(1)(2), 03, 44(2), 44(5), 44 (7c,d,e,j), 30,32, 34 and 17(2)(a) of Subsidiary Legislation 368.02, on his admission finds the accused guilty of the charges brought against him and condemns him to pay a fine (multa) of three thousand euro (€3,000) to be

paid immediately, orders the seizure of the corpus delicti, that is of vehicle Peugeot original registration S819 CEB, and disqualifies the accused from holding or obtaining a driving licence for a period of twelve (12) months which period starts to run as from today's midnight.
