Christian Roger Martin

The Court;

Having seen the accusations brought against **Christian Roger Martin** 46 years old, son of Roger and Nathalie nee Spiteri, born in Long Beach, California on the 25th February 1968, residing at block 7, Flat 3, Triq Enrico Mizzi, Ta' Xbiex and holder of Maltese ID card number 205700L;

With having on the 27th August 2014, at 0130hrs, in Trig Santa Rita Sliema;

- 1. Wilfully committed any spoil, damage or injury to or upon any movable or immovable property, which damage amounts to not more than one thousand, one hundred and sixty four Euro and sixty nine cents (€1,164.69), but however is more than one hundred and sixteen euro and forty seven (€116.47) to the detriment of Mario Barnett holder of identity card number 407646(M), and this in breach of Article 325(1)(b), of chapter 9 of the laws of Malta;
- 2. also having on the same date, time, place and circumstances wilfully disturbed the public good order or the public peace, and this in breach of Article 338(dd) of Chapter 9 of the laws of Malta;
- 3. also for having on the same date, time, place and circumstances even though in a state of intoxication, publicly uttered any obscene or indecent words, or made obscene acts or gestures and this in breach of Article 338(bb) of Chapter 9 of the Laws of Malta;
- 4. and also for having on the same date, time, place and circumstances, caused slight injuries on the person of Mario Barnett as certified by Dr.

David Fenech MD and this in breach of Article 221(1) of Chapter 9 of

the Laws of Malta;

The Court is also being humbly requested to issue a protection order in terms

of Article 412C, whereby it impedes the accused from approaching Jonathan

Ellul holder of ID card 357487(M) and Mario Barnett holder of ID card

number 5466(M) and their residences, and places that the latter frequent.

In case of guilt Court is requested to cause Christian Roger Marlin to pay

injured parties that amount to cover expenses which is established by the

Court for the damages incurred from the crime committed.

Having heard the plea of guilt as registered by the accused in today's' sitting being

the first sitting of these proceedings;

Having seen the records of the case;

Finds the accused guilty as charged;

Having seen articles 325(1)(b), 338(bb) (dd), 221(1) of Chapter 9 of the laws of Malta;

Having heard the prosecution's declaration that the accused has already made good

for all damages of which he is accused in the first charge;

Kopja Informali ta' Sentenza

Deals with the accused by conditionally discharging him with the specific condition

that he does not commit any other offence within a period of two (2) years from

today in terms of article 22 of Chapter 446 of the laws of Malta

The Court explained to the accused his obligations arising out of this judgement.

The Court also orders that these acts be transmitted to the attorney general within

the time prescribed by law since the prosecution did not have the consent of the

attorney general to try this case summarily.
