



3. L-access fuq il post sar fit 22 ta Settembru fis 2.30 ta wara nofs in nar. Access iehor minn barra sar ukol fit tnejn ta Awissu 2016 wara mistoqsijiet mghamula mill Bank of Valletta. 4. Kimron, Triq Erbatax ta Novembru, St. Venera
