


Din twaslek għal-kcina/kamral tal-ikel/"living" (6.1m x 2.7m) u kamra tal-banju (1.2m x 2.2m). Hemm bitha fuq il-


lemin (2.8m x 2.7m) u ohra faccata (51 sq.m.) Din il-bitha fiha xi kmamar imxatrin.





