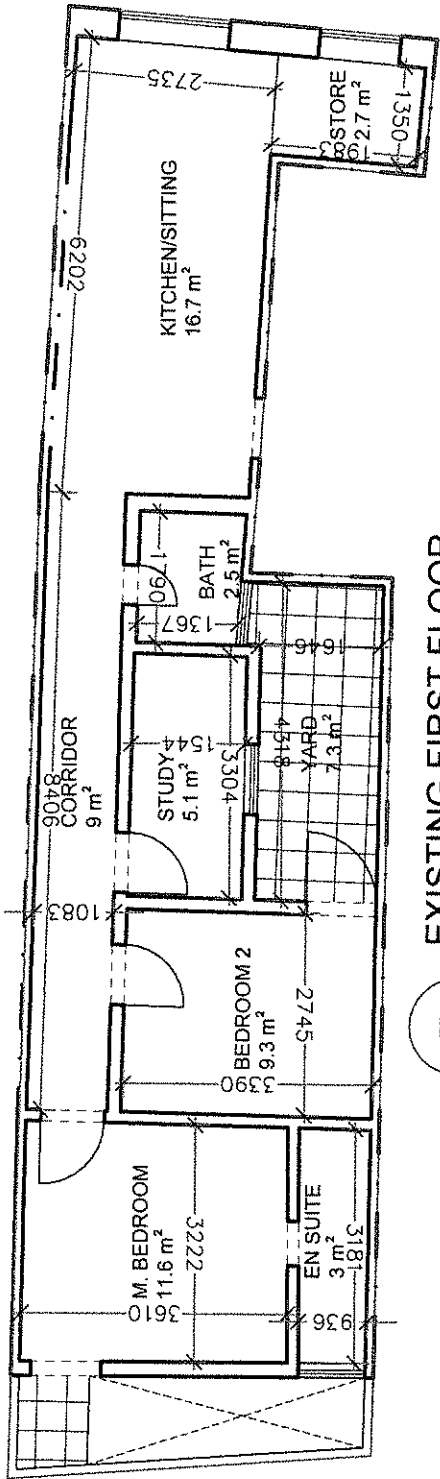


EXISTING FIRST FLOOR

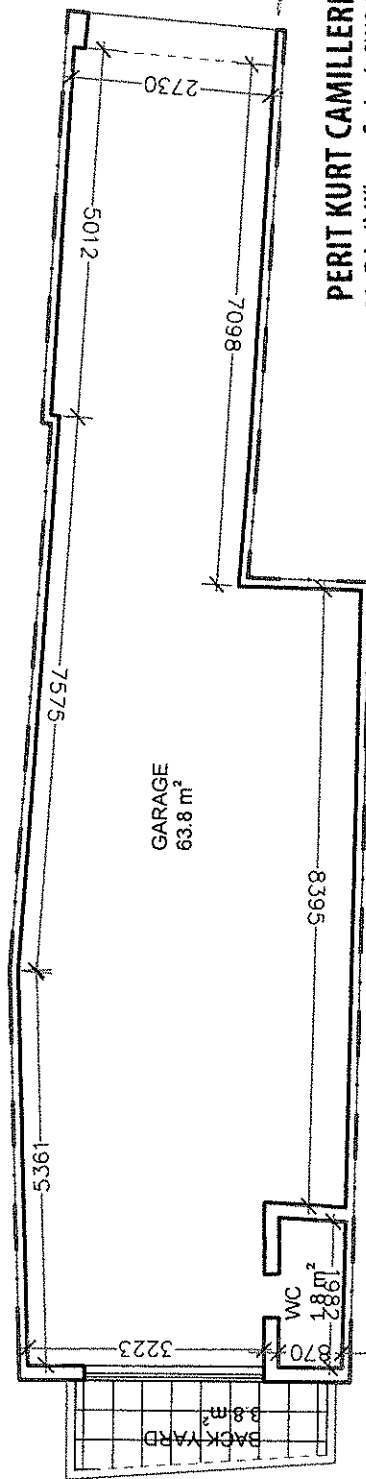
