
L-iskop

L-iskop ta' dan ir-rapport huwa li jippreżenta l-valur u d-dettalji tal-propjeta' immobili msemmija hawn taħt:

Sylvia Flats, Appartment Nru. 2, Triq Emmanuel Galizia, Ta' Xbiex.

Id-digriet tal-Qorti ġie mogħti nhar il-Ħamis 28 t' April 2022 u l-aċċess fuq il-post sar nhar il-Ħamis 6 t'Ottubru 2022, permezz ta' żgass.

Din il-valutazzjoni ġiet ippreparata abbaži ta' analiżi viżwali li saret tal-propjeta' hawn fuq imsemmija. Waqt l-ispezzjoni, ma saret l-ebda analiżi ta' l-istruttura u/jew tas-servizzi li jinsabu preżenti ġewwa l-propjeta' hawn fuq imsemmija.



Il-lokalita'

Jirriżulta li l-propjeta' hawn fuq imsemmiha tinsab f'kumpless residenzjali mibni fi Triq Emmanuel Galizia, kantuniera ma' Triq Emmanuel Galizia, Joe Flats, ġewwa Ta' Xbiex. Iż-żona hija waħda residenzjali u fil-vičinanzi taż-żona kummerċjali ta' Triq Testaferrata, kif ukoll ta' l-Empire Stadium ġewwa il-Gżira. L-imsemmi fond jinsab fil-vičinanzi ta' varjeta' ta' ħwienet u uffiċini. Diversi waqfiет tat-transport pubbliku jinsabu fil-vičinanzi tal-binja. Din l-akwata hija okkupata minn taħlita ta' residenti Maltin u barranin. L-inħawi huma relativament traffikuži kawża ta' l-ammont ta' ħwienet u postijiet kummerċjali li jinsabu fiż-żona. Fil-preżent, it-traffiku li jgħaddi mit-toroq ta' madwar il-binja huwa ta' karozzi żgħar, f'żewġ direzzjonijiet u jservi biss lir-residenti peress li t-triq hija pjuttost dejqa.



L-appartament internament immarkat bin-numru tnejn (2) fil-groundfloor level, formanti minn blokk ta' tnax-il (12) flat bla numru, iżda jgħib l-isem 'Sylvia Flats', fi Triq Emmanuel Galizia, qabel magħruġa bħala triq ġdida li tagħti għal Triq Princess Margaret, ġewwa Ta' Xbiex, liema blokk flats huwa konfinati mit-Tramuntana mal-imsemmija triq u mill-irjeħat l-oħra kollha ma' beni tal-kumpanija Gasan Properties Limited jew is-suċċessuri tagħha u liema blokk jaġħmel parti minn kumpless magħruf bħala 'Capri Court, qabel magħruf bħala 'Gasan Court', fi Triq Emmanuel Galizia, Ta' Xbiex, konfinanti l-imsemmi kumpless mill-Grigal mal-imsemmija triq, mix-Xlokk ma' Triq Giorgio Mitrovich, qabel triq ġdida li tagħti għal Triq Testaferrata u mit-Tramuntana ma' propjeta' tal-familja Camilleri jew l-aventi kawża tagħhom.

L-appartament huwa suġġet għaż-ċeċ-ċens annwu u perpetwu ta' erbgħa u tletin ewro u ħamsa u disgħin ċenteżmu (€34.95), bid-drittijiet u l-pertinenzi kollha tiegħu u soġġet għas-servituet riżultanti mill-pożizzjoni tiegħu favur il-propjeta' l-oħra sovrastanti fl-istess blokk. L-appartament għandu s-sistemi tal-katusi tad-drains tal-ilma u d-drenaġġ komuni tal-propjeta' sovrostanti u d-dritt ta' aċċess ta' hsara u manutenzjoni f'ħinijiet rägonevoli. Inkluż ukoll d-dritt ta' satellite dixx/televixin aerial u tank tal-ilma tal-kapaċita' ta' mhux iktar minn ħames mitt litru (500L) fuq il-bejt tal-blokk, fil-post indikat u bi dritt ta' aċċess f'każ ta' hsara u ta' manutenzjoni.


Inkluż ukoll l-obbligu 'pro rata' għal-ħlas ta' manutenzjoni u riparazzjoni tal-partijiet komuni u l-obbligu ta' tishieb fl-Owners Association tal-istess blokk meta din tiġi iffurmata. Inkluż ukoll wieħed minn tnax (1/12) parti indiċċa mill-partijiet intiżi għal-użu komuni, cioè l-entratura, taraġ indani, tromba u partijiet kollha intiżi għal-użu komuni.



Deskrizzjoni tal-Propjeta'

Il-propjeta' hija mibnija b'ħitan tal-brikks/franka u soqfa tal-konkos. Jidher li l-appartament ilu mitluq għal xi żmien b'xi xogħolijiet mibdija iżda mhux kompluti. It-tqassim tal-propjeta' huwa f'għamla kwadra, b'bithha interna f'nofs il-fond. Meta tidħol ġo l-appartament issib kuritur, *living room* fuq in-naħha tax-xellug u karma tas-sodda ħdejha. Faċċata tal-bieb ta' barra, wieħed isib il-kċina u karma tal-ikel u ħdejha hemm il-kamra tas-sodda prinċipali li għandha ħdejha karma tal-banju. Il-kuritur idur mal-bithha interna u fuq il-lemin ta' kif tidħol hemm ukoll *washroom*.

L-appartament għandu iktar minn ħamsa u ħamsin sena, u il-blokk tidher fir-ritratt mill-ajru li ttieħed fl-1967, anness f'Dokument E. Il-fond għandu madwar 88.6m^2 u jinsab fi stat abbandunat. L-ġħoli tal-propjeta' hija madwar 2.70 metri. Il-fond gie trasferit fis-16 ta' Frar 2010.



Fatturi interni

Il-propjeta' hija pjuttost kompattha bil-kcina u kamra tal-ikel separati mill-*living room*, żewġ kmamar tas-sodda u żewġt ikmamar tal-banju, b'waħda minnhom tintużha bħalha *washroom*. Il-fond ma għandux spazju estern għajr għal bitħa interna żgħira. Il-propjeta' thares fuq Triq Emmanuel Galizia. It-tqassim tal-propjeta' huwa pjuttost kwadru.

Il-propjeta' għandha madum taċ-ċeramika kif ukoll ħitan miksija u miżbugħha. Ix-xogħol fil-bitħa interna u l-aperturi tagħha jidher li huwa mibdi pero' għadu mhux komplut. Il-finituri madwar il-propjeta' kollha huma f'kundizzjoni ħażina, li jikkonsistu minn madum taċ-ċeramika, ħitan miżbugħha ġlieg dawk tal-kmamar tal-banju kif ukoll aperturi tał-aluminium bi ħiegħiġ *single glazing*. B'mod ġenerali, il-propjeta' tinsab f'kundizzjoni ħażina u jidher li soffrit diversi ħsarat kawża ta' l-ilma li qed jidhol b'mod kontinwu fil-fond. Jidher li bosta servizzi gew mgħoddija *surface* (fuq il-ħajt flok fi trinek) u l-biebien ta' gewwa għandhom bżonn jinbidlu. Il-propjeta' hija aċċessata minn Triq Emmanuel Galizia, fejn minn din it-triq hawn imsemmija, tiedhol ġo komun li jikkonsisti minn taraġ u mgħammra b'lift komuni. Il-komun tal-blokka għandu sistema ta' dawl u ilma, mqabbda mas-sistemi nazzjonali u il-blokka hija mqabbda mas-sistema tad-drenaġġ prinċipali. It-toroq tal-madwar huma kollha ffurmati kif ukoll asfaltati. Fil-madwar wieħed jista jsib il-kumditajiet kollha assocjati mal-ħajja ta' kuijum. Id-domanda għal propjetajiet simili fid-daqs u tqassim hija pjuttost għolja.

Il-faċċat tal-blokka huma kollha mikṣija u miżbugħa b'lewn ċar u naturali. It-taraġ li jwassal għal komun huwa lest bil-madum. L-aperturi tal-blokka m'humiex kollha l-istess, bil-maġġoranza tagħhom huma ta' aluminium ta' lewn abjad u l-puġġamani tal-gallariji huma ukoll ta' aluminium bajdani u tgħieg. Il-ħitan tal-komun huma kollha mikṣija u miżbugħa b'kulur abjad.

Madanakollu, anness f'Dokument E huwa r-rittratt li ttieħed mill-ajru fl-1967 li juri l-blokk diġa' mibni. Dan ifisser li l-fond huwa eskluż mill-liġijiet sanitarji li jirregolaw propjeta' li nbniet wara din is-sena – b'hekk il-fond jista' jitqies bħala konformi mal-liġijiet tal-ippjanar.

Il-propjeta' tinstab fl-iskema tal-iżvilupp u taqa' fi ħdan iż-żona residenzjali indikata fil-pjanijiet lokali b'referenza: *GT1 Policy Map*.




Valutazzjoni

Il-valutazzjoni kienet derivata billi ntuża il-metodu komparabbi ma' tranżazzjonijiet riċenti ta' propjeta' simili fl-istess lokalita'. Il-valutazzjoni tħejjet skond il-KTP Valuation Standards for Accredited Valuers. Kien innutat li appartamenti simili fil-madwar kienu jiswew madwar €2,850 kull metru kwadru. Meta tieħu inkonsiderazzjoni il-fatturi kollha li jħallu impatt fuq il-valur tal-propjeta', il-Perit hawn taħt iffirmat, jiddikjara il-valur ta' l-appartament fl-ammont ta' €250,000 (mitejn u ħamsin elf ewro).







Photo B - II-faċċata tal-blokk








Photo 02 – Rittratt tal-living room




Photo 04 – Rittratt tal-living room






Photo 07 – Rittratt tal-kċina




Photo 09 – Rittratt tal-kamra tas-sodda




Photo 10 – Rittratt tal-kamra tas-sodda








Photo 14 – Rittratt tal-kċina









Photo 16 – Rittratt tal-kċina







Photo 17 – Rittratt tal-kċina











Photo 21 – Rittratt tal-kamra tas-sodda







Photo 22 – Rittratt tal-kamra tas-sodda








Photo 24 – Ritratt tal-kamra tas-sodda




Photo 25 – Rittratt tal-kamra tas-sodda







Photo 26 – Rittratt tal-kamra tal-banju






Photo 27 – Rittratt tal-kamra tal-banju





Photo 28 – Rittratt tal-kamra tal-banju






Photo 29 – Rittratt tal-kamra tal-banju




Photo 30 – Rittratt tal-bitħha interna






Photo 33 – Ritratt tal-bitħha interna




Photo 34 – Ritratt tal-biċċa interna



EXISTING GROUND FLOOR PLAN




EXISTING ELEVATED GROUND FLOOR PLAN






EXISTING GROUND FLOOR PLAN




