Spezzjonajt lir-residenza li naghti deskrizzjoni tieghu hawn taht ghal fini ta' valuazzjoni.

It terran huwa ta kostruzzjoni antika – tipika ta terran u mezzanin fuq plot ta circa 5.5m (hamsa punt hames metri) fil wiesa.



Ghal fini ta valutazzjoni , wiehed ghandu jqies zewg punti barra il qies u l-post tal propjeta. Dawn huma li ls –sinjura Tabone ghexet u tghix f'dan il post u li ghandha 89 (disgha u tmenin) sena u li jithallas ic-cens perpetwu ta €13.60 (tleltax l-ewro u sittin centezmu).

L-art hija l-original, madum tal cement ippresat bid-disinn. L-aperturi gew mibdula maz zmien ghax il majjoranza huma tal aluminium lejwn id deheb.

Il bieb ta barra huwa ta l-injam u qieghed fi stat hazin. Ghandu partijiet tal hgieg bil ferro batuto jghamlu parti mil bieb. Il faccata tal binja u dan il bieb lihom ma jigu mizbughin u dan jwaqqa il post mad-dehra kif tasal ghalih.

Il zewg affarijiet li laqtuni kienu li hemm bleb intern, kif tidhol fi-entrata, li jghaqqad in terran 105 mal residenza fuqu, numru 103 (il mezzanin ta fuq il 105). 
